dents, and the invited guests.

First, the students of University of Yangon performed with 'Mya Kyun Nyo Nyo' (The Emerald Island) to honour the significant features of the university.

The State Counsellor launched the ceremony, and delivered a speech, recognizing the celebration is very significant for both the University of Yangon and the country.

She added the University

was established on 1 December 1920, and it 100<sup>th</sup> anniversary will mark on 1 December 2020. The joyous celebration of centennial has begun taking place, and the activities are expected to increase gradually during this period.

She also remarked the University of Yangon has possessed the great dignity of the country, and can be regarded as the mother of all the universities in the country.

When it was first established, its organizational structures imitated those of England universities. It was also one of the best universities in the Southeast Asia. Nearby Inya Lake, convocation hall, the large dioecious tree (Thit Pote Pin), Adipati Road and its large campus are its significant features to become one of the most attractive universities in the region.

## Second Pyithu Hluttaw's 14th regular session holds tenth-day meeting

THE tenth-day meeting of the 14th regular session of the Second Pyithu Hluttaw was held at the Pyithu Hluttaw meeting hall of the Hluttaw Building in Nay Pyi Taw yesterday, where asterisk-marked questions were asked and answered, a decision made on a bill and three reports read.

#### **Asterisk marked questions**

In the asterisk marked question and answer session questions raised by U Saw Tun Mya Aung of Papun constituency on plan to lay a power transmission line to Papun Town, U Aung Kyaw Kyaw Oo of Hline constituency on department responsible to move transformers and lighting poles obstructing municipal works and U Sai Ngaung Hsai Hein of Maukmai constituency on arrangements made to pro-

vide electricity to villages in the constituency were answered by Deputy Minister for Electricity and Energy U Khin Maung Win.

Similarly, questions relating to irrigation raised by U Steven of Kengtung constituency, U Pe Than of Myebon

constituency and U Se Ki Kaw of Mongkhat constituency, a question on amending rules to 2012 Farmland Law by U Nyan Hein of Thanbyuzayat constituency were answered by Deputy Minister for Agriculture, Livestock and Irrigation U Hla Kyaw.

## Decision on National Records and Archive Bill

Following the asterisk marked question and answer session Bill Committee member Dr Wai Phyo Aung submitted the agreeable and disagreeable amendments of the National Records and Archive Bill returned with amendments by Amyotha Hluttaw and obtained the decision of the Hluttaw to approve the bill after obtaining the comments of Ministry of Planning, Finance and Industry.

Next, Bill Committee secretary U Kyaw Soe Lin tabled a motion to submit the disagreed amendments to Pyidaungsu Hluttaw for its decision. Pyithu Hluttaw Speaker announced that the matter will be submitted to Pyidaungsu Hluttaw for discussion and decision.

### Annual reports of three committees read

Afterwards Pyithu Hluttaw Public Accounts Committee Annual Report, Pyithu Hluttaw Banking and Financial Development Committee Annual Report and Pyithu Hluttaw Investment and Industrial Development Committee Annual Report were read by committee members U Thein Tan, U Aung Soe and U Ohn Lwin respectively.

Pyithu Hluttaw Speaker made announcements for Hluttaw representatives who want to discuss the report to register their names after each report was read.

The 11<sup>th</sup>-day meeting of the second Pyithu Hluttaw's 14<sup>th</sup> regular session will be held on 4 December. — Aye Aye Thant (MNA)

## Amyotha Hluttaw passes Myanmar Insolvency Bill

THE 14<sup>th</sup> regular session of Second Amyotha Hluttaw held its 10th day meeting yesterday with raising questions and tabling a motion.

It also approved the Myanmar Insolvency Bill, after it was sent back by the Pyithu Hluttaw with recommendations.

#### Ten Ancient Cave Pagodas in Rakhine State

MP U Maung Kyaw Zan from Rakhine State constituency 9 asked the Union government to put ten ancient cave pagodas into the list of national cultural heritage areas in Rakhine State.

Deputy Minister for Religious Affairs and Culture replied that the caves are just ancient structures, and that they could not be recognized as the area of cultural heritages. However, these pagodas will be recorded in the list of ancient monuments and edifices conserved by the Department of Archaeology and National Museum.

#### **Control of illicit trades**

MP U Soe Thein from Kayah State constituency 9 asked the government about the control of illicit trade and conflict economy especially in drug trafficking.

Deputy Minister for Commerce U Aung Htoo said that the surge in illegal trade is due to a transition period from some unregistered businesses to reg-

istered one in private sector, and the ongoing process in rule of law and lasting peace. The Deputy Minister also said the government has formed anti-illicit trade units in nine States/Regions close to the neighbouring countries.

The Deputy Minister also said the government's anti-drug efforts, including the 865 cases taken to the courts with the arrest of 1,320 persons from 16 June 2018 to 23 November 2019. The Union Minister for Home Affairs is leading in eradication of drug trafficking, poppy cultivation, control of prohibited chemicals, treatments, rehabilitation, disseminating knowledge and educative campaigns. He also said the Ministry of Natural Resources and Environmental Conservation is taking various actions against illegal trade of jades, timbers and metals, while the Ministry of Planning, Finance and Industry has

set up 15 offices in States/Regions level, 26 offices in township level, 15 OSS camps and other checkpoints to control illegal trades.

The Deputy Minister also requested common people, Hluttaw representatives, media, and private business firms to join hands with the officials in fighting against the illegal trade.

## Role of Myanmar commercial attaches

MP U Aung Myo Latt from Mandalay Region constituency 5 asked about the role of commercial attaches assigned duties in foreign countries to improve Myanmar export sector in expanding crop markets of the country.

Deputy Minister U Aung Htoo also replied that the commercial attaches are collecting market information, import polices and rules, economic policies and strategies of respective coun-

tries. They are also explaining economic development, investment policy, laws, bylaws, rules and procedures of Myanmar to the officials and businesspersons of those countries. They have to deliver weekly, monthly, biannual and annual reports on the business information and market data of those countries. These sorts of information are published in the Commerce Journal and some publications online. They also give Myanmar business information asked by individuals or companies of foreign countries.

#### Branch office of district election commission in Matupi

MP U Larl Min Htan from Chin State constituency 10 asked to open a branch office of district election commission in Matupi Town of Chin State before 2020 General Election and to allocate budget for construction of its building in nearest financial year.

Member of Union Election Commission U Soe Yal replied plans have been made to open an affiliated office with Matupi Township Election Commission Office, and its office will be constructed in nearest finncial year as the land plot has been received for it.

## Projects of Zaykabar Company Limited in Thandaung Town

MP Naw Chirst Tun (a) Dr Ar Kar Moe asked about legitimacy of construction projects for roads, bridge, shops, waterfall and other sites carried out by Zaykabar Company Limited along Pathi Creek in Thandaung Town. The question was replied by Nay Pyi Taw Council Member U Nyi Tun.

## Approval of Myanmar Insolvency Bill

Then Amyotha Hluttaw Deputy Speaker U Aye Tha Aung announced the Myanmar Insolvency Bill after seeking approval of the House on the recommendations of Pyithu Hluttaw.

## Motion to allocate unused state-owned property

MP U Ko Ko Naing from the Sagaing Region constituency 8 tabled a motion to urge the Union government to allocate the unused state-owned property for addressing the shortage of city land in establishing public recreation places.

MP U Win Myint from the Magway Region constituency 8 supported the motion.

The Amyotha Hluttaw Deputy Speaker announced to submit the names of MPs who want to discuss the motion as it was agreed by the Hluttaw for discussion.

The State Counsellor continued that the government is renovating and upgrading the university during its centennial period by forming work committees for a master plan which is being implemented by a steering committee chaired by the Union Minister for Education.

To promote education quality and physical structures, a software committee and a hardware committee were formed.

She also recognized the adaptation of master plan for the university, including its organizational structure, management, policies and functions, to suit the developing situations. In accordance with the Myanmar Education Law 2015, the University of Yangon would be developed into an autonomous university soon after making preparations.

In the aspect of education reform, a faculty system will be established, and its curricula will be reviewed and developed. Its curricula and policy reform are intended for ensuring quality improvement, socioeconomic development, effective cooperation with international universities and easy student mobility.

Reform programme of the university includes the establishments of internal quality assurance system, applied research activities, internationalizations in cooperation with foreign universities and developing an e-library.

The State Counsellor also explained promoting physical structures of the university in developing a clean and safe campus, upgrading roads, creating a greening area along the Adipati Road without damaging its environment and historic buildings in accordance with the wills of new generation students, its alumni and the common people.

She added the clean water supply, flow of water, drainage system and safe wiring installations are also included in upgrading physical structures of the university.

In academic sector. the existing curricula of university will be upgraded to meet the needs in socioeconomics and education sectors of the country. The curricula reforms could help in cooperation with international institutions and student mobility, and could generate competent human resources for the country, while a credit transfer system would soon be developed for easy cooperation with foreign universities in student mobility.

The State Counsellor remarked promotion of education quality is very fundamental to upgrading the University of Yangon, adding that a university is an educative institution intended for developing good people.

She also concluded that education could help in human development and making right deci-

The State Counsellor commented it is not possible to judge a subject is better than any other subjects as all of these are useful, and advised to promote all the subjects in developing education sector. The values of subjects depend on the users of these subjects. It is expected to apply these subjects properly.

She also said the government will support harmonious development of subjects and generating capable students who could create a developed country.

She remarked that Myanmar is still a developing country, and that young people are responsible for the development of the country, and they should be proud of this duty.

In conclusions, the State Counsellor called for a successful holding of centennial celebration with the participations of new generation students, alumni and people.

He said the increasing momentum of digital technology has been a part of  $4^{\rm th}$  industrial revolution in the past three decades, leading to great impacts on many sectors, and people are finding information and entertainment programmes on mobile gadgets as the mobile SIM cards has outnumbered the country's population.

He also pointed out the importance of information manage-

Stan Suu Kyi attended and addressed an opening ceremony of the Medical Skill, Simulation and Research Center held in the compound of University of Medicine 1, Yangon yesterday afternoon.

Present at the event were Union Ministers Lt-Gen Kyaw Swe, Dr Pe Myint, U Min Thu, Dr Myo Thein Gyi and Dr Myint Htwe, Peace Commission Chairman Dr Tin Myo Win, Yangon Region Chief Minister U Phyo Min Thein, Yangon Region Hluttaw Speaker U Tin Maung Tun, Region government ministers, Ministry of Health and Sports Permanent Secretary, Rectors of medical and related universities,

department heads, students, donors and invited guests.

The Medicial Skill, Simulation and Research Center was opened by State Counsellor Daw Aung San Suu Kyi, Union Ministers Lt-Gen Kyaw Swe, Dr Pe Myint, U Min Thu, Dr Myo Thein Gyi and Dr Myint Htwe, Peace Commission Chairman Dr Tin Myo Win, Yangon Region Chief Minister U Phyo Min Thein and Yangon Region Hluttaw Speaker U Tin Maung Tun cutting the ceremonial ribbon.

Afterwards, the State Counsellor pressed a button to unveil the signboard of the medical simulation training centre and research building and sprinkled

scented water onto the commemorative plaque.

In her address at the event the State Counsellor spoke of the day being a dawn of another unique success in the teaching and practising history of medical and related universities. This will allow for the systematic teaching and learning of international level medical expertise by doctors, nurses, medical experts and health care personnel who play a main role in public health care works.

Construction of the medical simulation training centre and research building commenced in January 2018 and it took nearly two years to be completed.

Now that the building was constructed and machineries and equipments installed, utilization can commence. More than K 12,000 million was used for it with the State allocating more than K 9,800 million and local and foreign donors donating more than K 2,300 million worth of cash and kind.

It is a proud moment to establish such training and research centre that never existed before in the medical teaching and learning history of Myanmar. It was established in the compound of University of Medicine 1 Yangon. The centre was aimed for 16 medical and related and universities as well as for 50 nurse and mid-wife training schools. Glad to know that another one will be constructed in Mandalay for upper Myanmar. Union Minister for Health and Sports Dr Myint Htwe was enthusiastically striving toward implementing this.

In fact we still need to do more for our country's medical education teaching and training to reach international level. We'll have to study how to catch up if we were left behind. Now is the time when technology developments were progressing rapidly and the same goes with medical technologies too. The quality of the doctors, nurses and health care technicians are directly related to patients' livelihood, overcoming illnesses and recovery. It is a matter of continuously studying the developing technologies to uplifting own capability

and quality.

Another matter to emphasize is research works of the universities. Research plays a vital role in the existence and development or progress of universities. Progress and development in research greatly support a country's development.

Among the world universities, the level of our universities rises. However, compared to other universities in ASEAN countries, it had dropped. I asked why? The answer was the rapid development and progress of ASEAN universities. These universities were progressing mainly due to research. This was where we'll have to reinforce.

In research works, medical universities as well as other universities in our country are to use modern and developed lab and equipment. Much need to be done toward development in research. The State was providing more and more funds for development in research works. Starting from fiscal year 2017-2018, the Ministry of Health and Sports was specially provided with more funds. At the moment, an increasing numbers of health care personnel were reading papers and making presentations at international research conferences. Post graduate, master and doctorate students need to make more efforts toward producing more international level research papers. They need to be more involved in international medical area.

Medical and related universities ought to conduct more medical research with Medical Research Department and National Laboratory. Here they need not be down hearted. If we are left behind, put more efforts with a belief that there are more roads left to be taken up ahead.

Learning and practicing medical expertise was not as easy as thought. There were situations where a patients feeling pain and fatigue need to be taken into consideration. In international workshops and discussion, mannequins, donated body parts, medicine and equipments were used to simulate real life situations. This was similar to using simulators to train pilots with

developing technologies rather than using an actual airplane. Due to medical simulation training centre and research department, doctors and nurses can practice repeatedly until the actual treatment work can be conducted without endangering the patient.

In this department, clinical skill as well as non-technical skill including team work, communication and leadership subjects can be taught. But I don't want to encourage the mindset of wanting to become a leader. Some just want to be a leader. Who was following? More need to be done toward cooperating.

It will also be teaching management, professionalism and medical ethics. This was very good. These are soft skills that

are required everywhere.

A doctor must not only be skilled and learned in medicine. He/she must be an expert in social skills. It was good that arrangements were made to teach this too even though it would be a bit difficult to teach this with mannequins.

Research was essential to know the requirement of the country and to resolve problems. Post graduate students, specialist and professor are urged to conduct more research works that could development relevant subjects as well as to resolve problems faced by the patients. Publish and utilize the outcome results of the research.

For the medical simulation training and research center building to run smoothly, human resources need to be trained. Systematic management and administration is required for sustainability. The Union Minister for Health and Sports was instructed to provide required training expenses as well as medicines and equipments. Material and human resources need to be replenished in order for the department to run successfully and achieve good results. Teachers and students are urged to use the training and research centre to raise public health care quality.

Local and international donors provided much support toward establishment of this centre. Cadaveric Laboratory, Microsurgical Training Lab, Simulation Operation Theatre, Emergency Department, Simulation Intensive Care Unit, Labour Room, Scope Simulator and Research Laboratory as well as Audio Visual System were said to be donated. Thanks to all. Help and assistant provided to state projects are valued. Thank to the organizations and people who helped toward establishing this centre. May this centre benefit the country and people in the health care sector for long said the State Counsellor.

Afterwards the State Counsellor and event attendees took commemorative group photo and inspected the research centre.

Nine non-technical skill courses and 16 technical skill courses will be conducted in the eight storey 192 x 90 ft. medical skill, simulation center and research building. — MNA

## SWRR Union Minister Dr Win Myat Aye discusses resettlement plans, closure of IDP camps in Sittway

UNION Minister for Social Welfare, Relief and Resettlement Dr Win Myat Aye explained the resettlement programmes and the National Strategy for the Closure of IDP camps at the U Ottama Hall in Sittway, Rakhine State, on 2 December afternoon.

The Union Minister said the relevant ministries are trying to emerge a suitable State Constitution that is required for rule of laws, socioeconomic development national reconciliation and internal peace, and a federal democratic union as socioeconomic development is interrelated with peace and development of the country.

He talked about the ministry's works in developing human resources that can support socioeconomic development of the country in accordance with the sustainable development plan of the country.

The Union Minister re-

marked that the armed conflicts have left many internally displaced persons at the IDP camps in Kachin, Shan, Kayin and Rakhine states, and the prolonged existence of these camps would hinder development of the country.

He said the National Strategy for the Closure of IDP camps must be implemented in cooperation with civil societies, INGOs, UN agencies and social organizations.

The strategy was adopted in 2018, and the monthly cash assistance is being given to the internally displaced persons, with the total amount of over K 1.8 billion up to date.

The Ministry of Social Welfare, Relief and Resettlement is taking up resettlement and socioeconomic development committee out of the four work committees for peace and development in Rakhine State.

He concluded his speech with suggestions on drawing appropriate work plans to meet the specific needs in respective states and regions.

Then, the Director General of Department of Disaster Management detailed the strategy, and the Union Minister, the Chief Minister of Rakhine State and officials replied the questions of attendees about closures of IDP camps in Myebon and Kyauk-phyu townships, possible participations of civil communities, providing assistance in education, health, livelihood, security and the right to freedom of movement for IDPs, contribution of community-based organizations in drafting state-level work plans and allocation of budgets.

The meeting was attended by the ministers of Rakhine State government, Hluttaw MPs, representatives of IDP camps, women committees, civil communities, Sittway University Union, Chin charity youth organizations and the representatives from UN agencies in Myanmar.—MNA



When experts and representatives review the conditions to revise the legal minimum wage, they should take into consideration long-term stability at the worksite and ensure that the minimum wage supports the country's GDP and economic development

## Nat statues selling well at Mandalay carving market

TRADITIONAL figures of Mandalay sculptors. Nats, spirits worshipped by some people in Myanmar, are enjoying a high demand in the Mandalay carving market, said

At present, the industry is faced with shortage of wood for carving and low demand in the local market. Therefore,

sculptors are prioritizing small statutes portraying ancient Myanmar culture as those carvings are being purchased by tourists as souvenirs.

"Since 2017, wood carvings showing the ancient design of the Ava period have primarily been sold," said U Naing Lin, a sculptor from Mandalay. "The Thailand market purchase 37 Nat figures and then, they resell them to international markets.

Sculptures sized 2-3 feet are mostly purchased as they are fit for transportation. Sculptures measuring 10-15 feet are rarely traded. There is demand only from hotels in the local market," he added.

Mandalay is welcoming more tourists year over year. Once the high season starts, the Mandalay carving market teems with buyers, according to shops selling sculptures.

Myanmar sculptures are popular in China, Thailand, and Laos. Carvings, priced K10,000-100,000, depending on the quality of wood, size, and design, are selling well. — Min Htet Aung (Mandalay Sub-Printing House) (Translated by Ei Myat Mon)

## Narcotic drugs confiscated in four townships

squad No.27 of Loilem searched the house of Aik Kyaw and Ma Nam Kham Lu (a) Nam Aye Lu in No.1 Ward in Mongshu Town and seized 4,000 stimulant tablets, 1 kg of raw heroin and Myanmar currency notes amounted K 80,000.

On the same day, Tatmadaw personnel searched a hut in the farm near Kun Taw Village, Mabein Township and seized 10,600 stimulant tablets from Ma Hla Win who was found in the hut.

Police filed charges against them under the Anti-narcotic Drugs and Psychotropic Substances Law, according to Myanmar Police Force. — GNLM (Translated by Kyaw Zin Tun)

## Local gold prices expected to extend their drop on weak global cues

WITH gold prices sliding in the global market, the price of the yellow metal in the domestic market is likely to continue falling, according to gold traders.

"Global gold price has dipped. The local currency is gaining against the dollar in the internal forex market. Gold price is expected to extend its drop this month," said U Myo Myint, chair of the Yangon Region Gold Entrepreneurs Association.

In early September, the price of pure gold crossed K1.3 million per tical (0.578 ounces, or 0.016 kilograms) in the domestic market, tracking global cues and rumors in the local banking industry. Then, it dropped to K1.175 million on 2 December.

"Despite the price drop, regular trading is being witnessed in the domestic market. About

With global gold prices on the uptick, the domestic price hit fresh highs this year, reaching K1,000,000 per tical between 17 January and 21 February, crossing K1,100,000 (22 June to 7 August), climbing to 1,200,000 (7 August-4 September), and then reaching a fresh peak of K1,300,000 on 5 September.

According to gold traders, the lowest price for gold in June was K1,223,800 (14 September) and the highest was K1,307,000 (5 September). In October, the gold price touched the lowest level of K1,211,500 on 1 October and the highest level of K1,229,000 on 10 October. In November, the price moved in the range of 1,219,400 (2 November) and K1,173,000 (28 November), according to gold traders. — Nyein Nyein (*Translated by Ei Myat Mon*)

## Imports exceed exports in Myanmar's trade with Singapore in 2018-2019FY

THE value of Myanmar's imports surpassed exports in bilateral trade with Singapore in the 2018-2019 Financial year, according to data from the Ministry of Commerce.

Singapore is Myanmar's second largest trading partner in the region, after Thailand. In the previous fiscal, Myanmar's exports to Singapore were registered at just US\$329.8 million, while imports were valued at \$3.15 billion, with total trade pegged at \$3.486 billion.

Myanmar exports agricultural products, footwear, textiles and clothing, minerals, and animal products to Singapore, while it imports plastic, fuel oil, capital goods, intermediate goods,

rate of Investment and Company Administration, Singapore ranked first among foreign investors with the largest investments in the previous Financial year, bringing in \$2.4 billion. In the current 2019-2020FY, Singapore-listed companies have discussed investing in Myanmar's energy and banking businesses with the Myanmar Investment Commission, and there is potential to increase investments, said U Thant Sin Lwin, Director-General of the DICA, at the Myanmar-Singapore Business Summit 2019, held on 14 November at the Novotel Yangon Max.

THE Myanmar Investment Commission (MIC), at a recent meeting, approved and endorsed investments of US\$857.29 million from six foreign enterprises along with seven domestic investment projects with estimated capitals of K269.3 billion and \$1.486 million.

Four foreign businesses were given the go-ahead by the MIC and the proposals of two foreign enterprises were endorsed by the Ayeyawady Region Investment Committee.

The investments will flow into the electricity, real estate, transportation, and manufacturing sectors. The projects are expected to create over 3,000 jobs for local residents.

Meanwhile, the proposals of three domestic enterprises were approved by the MIC and four were endorsed by the Mandalay Region, Ayeyawady Region, and Mon State investment committees.

The domestic projects will be executed in the manufacturing, real estate, hotel, and livestock and fisheries sectors, and create over 1,460 jobs. The Myanmar Investment Law allows regional and state Investment Committees to endorse local and foreign proposals, where the initial investment does not exceed K6 billion, or \$5 million, with the aim of simplifying the verification of investment projects. — Nyein Nyein (*Translated by Ei Myat Mon*)

THE value of goods imported by the public sector between 1 October and 22 November in the 2019-2020 financial year showed a decline of US\$109 million in all three import groups — capital goods, intermediate goods, and consumer goods — compared with the year-ago period.

Meanwhile, compared with the corresponding period of last

year, private sector imports registered an increase of \$188 million in two groups — capital goods and intermediate goods.

The total import figure stood at \$2.62 billion, an increase of \$79 million from \$2.54 billion registered in the year-ago period, according to data released by the Ministry of Commerce.

As of 22 November, capital

goods, such as auto parts, vehicles, machines, steel, and airplane parts were brought into the country by the public and private sector, with an estimated import value of \$890.2 million. The figure was \$57 million higher compared to the same period in the 2018-2019FY.

Meanwhile, Myanmar imported consumer products worth

\$481.18 million, including pharmaceuticals, cosmetics, and palm oil. Both private and public sector imports of consumer products showed a decrease of \$6 million compared with the same period of the previous fiscal.

Intermediate goods make up a large share of Myanmar's imports, with petroleum products and plastic raw materials being the main import items. In the current fiscal, imports of raw materials declined by \$12.8 million from the year-ago period to reach an estimated \$919 million.

During the same period, raw materials worth \$344 million were also imported for the Cut-Make-Pack (CMP) garment sector. — GNLM (Translated by Ei Myat Mon)



# China suspends Hong Kong visits by US military ships, aircraft, sanctions US NGOs

BEIJING — The Chinese government has decided to suspend reviewing applications to visit Hong Kong by US military ships and aircraft starting Monday, foreign ministry spokesperson HuaChunying said.

China will also take sanctions against some US non-governmental organizations (NGOs) for their role in the disturbances in Hong Kong, Hua said at a press conference.

The NGOs include the National Endowment for Democracy, National Democratic Institute for International Affairs, International Republican Institute, Human Rights Watch and Freedom House.

A lot of facts and evidence have shown that the aforementioned NGOs supported anti-China rioters in Hong Kong in various ways, abetted their extreme and violent criminal behavior and incited separatist activities for "Hong Kong independence", Hua said, adding that these organizations bear major responsibilities for Hong Kong's chaotic situation and should be sanctioned and pay their price.

The spokesperson said the United States has seriously violated the international law and basic norms governing international relations, and interfered in China's internal affairs by signing the so-called Hong Kong Human Rights and Democracy Act of 2019 into law despite China's firm opposition.

"China urges the US to correct its mistake and stop meddling in Hong Kong affairs or interfering in China's other internal affairs by any word and act," Hua said.

China will take further necessary actions in accordance with the development of the situation to firmly defend the stability and prosperity of Hong Kong and safeguard national sovereignty, security and development interests, she said.

## Japan promises \$3 bil in funding to ASEAN nations from 2020

TOKYO — Japan has promised \$3 billion in investment and loans to the Association of Southeast Asian Nations to boost development in the fast-growing region, Foreign Minister ToshimitsuMotegi said Monday.

The public and private sectors will make the contribution over three years from 2020 to 2022 as part of Japan's efforts to improve infrastructure, women's empowerment and protection of the natural environment, he said.

The announcement follows Prime Minister Shinzo Abe's promise in early November to double investment and loans to the 10-nation group as he looks to garner support for his vision of a "free and open" Indo-Pacific as a counter to China's growing influence. In a speech in Tokyo, Motegi said the move showcases Japan's commitment to "free and fair economic development in ASEAN by providing economic options in all of its corners."

"Economic cooperation is not just about paying for infrastructure construction. We always come in with a long-term vision to create local jobs, to build capacity, to nurture human resources that will become an engine for growth," he said at a symposium organized by the Japan Institute of International Affairs. Of the total, \$1.2 billion will come from the government-funded Japan International Cooperation Agency. — Kyodo News ■

## Australia unveils multimillion dollar counterintelligence program


SYDNEY — The Australian government on Monday unveiled a plan to create a new counterintelligence task force to strengthen the country's response to foreign interference.

Prime Minister Scott Morrison said the planned AU\$88 million (\$59.6 million) Counter Foreign Interference Taskforce would help to "disrupt and deter anyone attempting to undermine our national interests."

The plan, developed on the advice of Canberra's intelligence agencies, comes amid increased concern about national security following claims of Chinese espionage and a cyberattack on the country's parliamentary network.

"Foreign interference comes from many, many different sources and it's important that we have the capacity to deal with it," Morrison said. "It's an evolving threat and it's also been a building and evolving response."

In November, local media reported a Chinese spy ring allegedly attempted to plant an agent in the nation's parliament. According to media organ-

ization Nine, Bo "Nick" Zhao, a Melbourne-based luxury car dealer was approached by a Chinese intelligence group offering AU\$1 million to fund his campaign for a lower house seat in last May's general election.

Zhao was reportedly found dead in a Melbourne motel room after he disclosed the offer to Australian intelligence officials.

Further, the prime minister

in February accused a "sophisticated state actor" of breaching the parliament's computer network in a cyberattack that allowed access to documents of the nation's three major political parties.

Reuters news agency reported in September that sources within Australian intelligence deemed China responsible for the attack. — Kyodo News

### Delhi: AIDWA, AIDSO members protest crimes against women

NEW DELHI (India) — Members of All India Democratic Women's Association (AIDWA) and All India Democratic Students Organisation (AIDSO) on Monday staged a protest at the JantarMantarhere to protest the crime against women.

The protestors blocked the traffic at the Jantar Mantar, shouting slogans such as — 'We want justice'. "The Hyderabad case was a trigger. Even after that, the rape cases have not stopped. There is just a continuous rise in the rape cases from across India," said a protestor.

A veterinarian was brutally gang-raped and killed by four

persons before they burnt her body in Shamshabad in Telangana's Ranga Reddy district last week. The accused have been arrested by the Cyberabad Police.

Earlier in the day, the issue was even raised in the LokSabha with Speaker Om Birla stating: "The Parliament is worried over the incidents happening across the nation."

Defence Minister Rajnath Singh said that the government is prepared to enact the strongest provision in law to check incidents of heinous crimes rape and murder case and have a discussion in Parliament on the issue of crime against women. — ANI

## US House panel to meet on Trump impeachment charges

WASHINGTON (United States) -A Congressional panel will begin drawing up charges against President Donald Trump on Wednesday as the likelihood grows of his becoming only the third US leader ever impeached.

However, Trump's attorney signaled on Sunday night that the White House won't send anyone to the hearings, at least not right

"We cannot fairly be expected to participate in a hearing while the witnesses are yet to be named and while it remains unclear whether the Judiciary Committee will afford the President a fair process through additional hearings," White House counsel Pat Cipollone wrote in a letter to Jerry Nadler, the Democratic chairman of the House Judiciary

Committee.

But Cipollone also did not rule out White House participa-

tion in the hearings entirely, instead requesting further details from Nadler on how the inquiry

will be conducted and saying he will give him an answer by next Friday.

Trump has been unable to quash allegations in the House of Representatives investigation that he illegally sought help from Ukraine to obtain dirt on his domestic political rivals, including possible 2020 challenger Joe Biden.

Nadler's committee meets on Wednesday to begin determining whether the evidence compiled in the investigative phase of the process meets the constitutional impeachment standard of "treason, bribery, or other high crimes and misdemeanors."

The committee is expected to consider at least four counts, or articles of impeachment, including abuse of power, bribery,

contempt of Congress and obstruction of justice.

"The president has accepted or enlisted foreign nations to interfere in our upcoming elections," said House impeachment leader Adam Schiff, a Democrat, in a November 25 statement.

"This is an urgent matter that cannot wait if we are to protect the nation's security and the integrity of our elections."

Trump and Republicans continue to brand the accusations and process as a political "witch

"This is a complete American waste of time," said Doug Collins, who as the leading Republican on the Judiciary Committee will lead that party's counterattack. He appeared on "Fox News Sunday."—AFP ■

### Russia cements role as gas 'kingpin' with three new pipelines

MOSCOW (Russia) — Russian President Vladimir Putin and Chinese leader Xi Jinping launch Monday a gas pipeline that is the first of three ambitious projects intended to cement Moscow's role as top gas exporter.

Putin and Xi are to inaugurate by video link-up the "Power of Siberia" pipeline, sending Siberian gas to China in a move that will strengthen their ties amid Moscow's confrontation with the West. Russia is also planning to soon launch two more gas pipelines that will ramp up supplies to Europe while bypassing Ukraine.

TurkStream, which Putin and Turkish leader Recep Tayyip Erdogan hope to launch in January, is to transport Russian gas to Turkey.

Nord Stream-2, which would double Russian gas volumes to Germany, is expected to go online in mid-2020. Analysts said the three projects have long-term economic and political benefits for Russia, which has inserted  $itself\,between\,European\,markets$ to the west and the rapidly growing Chinese market to the east.

"Russia is not only creating new income streams, but hedging its bets and bolstering its position strategically," said energy analyst Andrew Hill.

"The ability to play one off against the other will not have been lost on either Gazprom or the Kremlin," Hill, who leads the S&P Global Platts EMEA gas and power analytics team, wrote in a blog post. He said the three projects were a sign that the Russian gas industry—"this kingpin of the global gas sector" — was becoming more mature.

Putin's spokesman Dmitry Peskov said the significance of the 3,000-kilometre (1,850-mile) Power of Siberia pipeline running from remote regions of East Siberia to Blagoveshchensk on the Chinese border was hard to overestimate.

"This is important for our country, this is important for China," he said ahead of the launch, stressing that the project would create jobs and infrastructure in Russia's Far East. — AFP ■

## Morales victim of 'coup,' says AMLO during first-term celebration

ican president Andres Manuel Lopez Obrador said Sunday that former Bolivian leader Evo Morales was the "victim of a coup d'etat."

The leftist president, nicknamed AMLO, celebrated his first year in office with a speech to throngs of supporters in Mex-

While detailing the ongoing fight against corruption and budget and tax policies, Lopez Obrador touched on Mexico's foreign policy by recalling his

MEXICO CITY (Mexico) — Mex-government's decision to accept Morales as an asylum seeker while discussing Mexico's foreign policy.

> "Evo was the victim of a coup d'etat! And from Mexico, we tell the world, 'Yes to democracy, no to militarism!" AMLO said during the rally in the central Plaza del Zocalo.

> The square was packed with people, and musical groups performed alongside AMLO's

It also marked the first time that Lopez Obrador, who has been in office for a year, spoke directly about the circumstances that led to Morales's departure from Bolivia.

Morales resigned on November 10 amid swelling protests over what political opponents said was his rigging of October 20 elections.

He fled to Mexico the following day after losing the support of the military and police, claiming to be the victim of a coup.

While echoing Morales's claim Sunday, AMLO called the exiled leader "our brother, who represents with dignity the majority of indigenous people of Bolivia."

Morales has yet to meet publicly with Lopez Obrador. He was welcomed on arrival to Mexico by Foreign Minister Marcelo Ebrard.

Lopez Obrador's one-year anniversary was marred when a shootout broke out Saturday afternoon near the US border between suspected drug traffickers and police, leaving at least 21 dead.

Shooting continued into early Sunday, and authorities said that four of those killed were police, 14 were suspected criminals and another three bodies were unidentified.

The shootout comes after Lopez Obrador warned he would not allow the US to conduct cross-border armed operations against drug cartels in the country. — AFP ■
