## Over 300 nationals return from Europe, Egypt, Hong Kong by relief flight

THE chartered flight of Titan Airlines, organized by the Myanmar Embassy in Brussel, Belgium, landed at Yangon International Airport bringing 175 citizens from Belgium, the Netherlands and its near region, and Egypt and its near region back home yesterday

morning.

Moreover, a total of 129 Myanmar citizens including 102 seamen and 2 students from Taiwan (Chinese Taipei) also returned home in the same morning by a relief flight of China Airlines organized by the Consulate-General of Myanmar in Hong Kong.

The Ministry of Labour, Immigration and Population, the Ministry of Health and Sports and the Yangon Region government arranged 14-day quarantine at specific places or designated hotels, followed by the 7-day home quarantine. The Ministry of Foreign Affairs is working with the relevant ministries and its missions in foreign countries for the repatriation of citizens abroad in accordance with the guidelines of the National-Level Committee on Prevention, Control and Treatment of COV-ID-19.—MNA



### Myanmar imports over \$1 bln worth machinery, spare parts as of July-end

THE import value of Myanmar's machinery and spare parts has estimated at over US\$1 billion between October and July of the financial year 2019-2020, the Ministry of Commerce's data indicated.

Similarly, the country imported \$753 million worth vehicles and spare parts.

Imports of commercial vehicles and machinery have been permitted through seaports and three border crossings — Muse, Myawady, and Tachilek.

"Starting from 1 January, imports of commercial vehicles on a company licence are not allowed. Importers are required to operate a car showroom in line with the prescribed rules and regulations. However, the new policy can pose difficulties for traders conducting business on a manageable scale," said importers.

Under the 2021 vehicle import policy, 2019 will be the oldest model to be issued an import permit for private cars with non-commercial purpose, according to the press release of the Commerce Ministry.

Except for machinery, all import vehicles must be lefthand drive under the 2021 vehicle import policy.

When individuals import vehicles with engines under 1,350 CC, the model year must be 2019 and later. Business people can import passenger vehicles such as mini-bus, city bus, express bus and commercial trucks manufactured in 2017 and later.

Under FOC Free-of-

Charge licence system, fire trucks, ambulances and hearse vehicles manufactured in 2012 or later are allowed for import.

The country allows to bring in heavy-duty vehicles as long as they are 15 years old or less. Heavy equipment includes excavators, bulldozers, wheel loaders, vibratory roller, clamp loader, motor grader, road roller compactor, bridge crane, gantry crane, tower crane, pilling machine, crawler drill/ crane, mobile crane, rough-terrain crane, forklift, boom lift, and asphalt finisher.

Myanmar cuts tariff on import of private cars and Semi-Knocked Down vehicles amid COVID-19 the impacts. This move is likely to bring down the prices of vehicles with engines above 1,500 CC. The dealers pointed out that the price is possible to drop by K2 to 15 million depending on vehicle brand and specifications.

The Ministry of Planning, Finance and Industry notified on 29 July that the government cut the tax on the importation of private cars with non-commercial purpose and SKD vehicles assembled in Myanmar starting from 1 August. It is part of the measures to remedy the businesses slowdown caused by the coronavirus pandemic.

The government also lowered Customs duty from 30 to 20 per cent on imported private cars with the engine under 2,000 CC and 40 to 30 per cent on vehicles with 2,001 CC and above. Meanwhile, the locally assembled cars under the SKD system were totally exempted from 10 per cent tax. Additionally, tariffs on SKD vehicles with 2001 CC and above were reduced from 20 to 5 per cent.

Additionally, starting from 7 August, registration fees at the Road Transport Administration Department (RTAD) on FOB price of the private vehicles were reduced from 30 to 15 per cent for vehicles with 1,500 CC and above, 50 to 25 per cent for vehicles with 1,351-2,000 CC, 80 to 40 per cent for cars with 2,001-5,000 CC and 120 to 60 per cent for cars with 5,001 CC and above respectively, the RTAD stated.

However, tax cuts still do not cover special goods tax, commercial tax and income tax to hold the vehicle ownership status. — Htet Myat (Turneleted by Fi Mart Mon)

### Over 100,000 bags from reserved rice sold at fairer price within 3 months

A total of 100,100 bags (108 pounds per bag) from reserved rice have been sold between 10 July and 3 October 2020, according to Myanmar Rice Federation (MRF).

Of them, Yangon traders made the most significant purchase with 61,307 bags, followed by about 701,689 bags are left to sell, MRF data showed.

Regarding the rice purchase at a much fairer price, those interested retailers and factories can contact through mobile numbers 09-694386994/5 of MRF and 09-694386996 of Myanmar Rice and The retailers in Yangon Region can also buy them at K23,200 per bag through the delivery system, with a minimum order of 10 bags per batch, MRF stated.

It is the government's move to sell the rice at K1,000 per pyi (2.13 kg) which is much fairer price than the prevailing market price. MRF is supporting the government's plan with non-profit, the federation reported.

Additionally, 8,273 bags are sold in Mandalay Region, while 7,700 in Nay Pyi Taw, 4,400 in Mon State, 2,000 each in Chin and Kayah states, 1,300 in Bago Region, 800 in Magway Region, 700 in Ayeyawady Region and 100 in Sagaing Region.

As of 3 October, 100,100 bags have been sold to retailers, and Paddy Traders Association. For any enquiry, the retailers can call mobile numbers 09 780173960, 09 758227837 of MRF.

At present, MRF purchased the rice bags at K22,400 per pack from the Consumer Affairs Department and to pay the storage charges, and the federation sells the rice to the registered retailers at K22,800 per 108-pound bag at the warehouses.

The Ministry of Commerce, Myanmar Inspection and Testing Service (MITS), the authorized organization of the State and MRF implemented rice reserve scheme on 30 April. The state's emergency rice reserve

#### Advance voting process for local voters outside their constituencies in 2020 General Election

- Heads of trainings, schools, hospitals and jails are to contact the sub-election commissions to get documents of Form 15.
- They must return these documents to sub-commission of respective townships by 26 August 2020 after the documents are filled by the voters.
- Sub-election commission of respective townships must send ballot papers and envelopes for advance voting to the trainings, schools, hospitals and jails by 7 October 2020.
- Advance voting must be organized at trainings, schools, hospitals and jails on their appropriate day from 8 October 2020 to 21 October 2020.
- The envelopes containing ballot papers must be sent back to sub-election commission of respective townships by 4 pm on 8 November 2020.

## Advice to people in Nay Pyi Taw

- 1. People should not illegally come to Nay Pyi Taw. If a person comes back from other places to Nay Pyi Taw, he/she needs to inform and receive medical examination. The charge for COVID-19 tests has been considerably reduced.
- 2. It has been learnt that some people get out of the cars on the Yangon-Mandalay Expressway and some old roads, and then they entered into Nay Pyi Taw via motorcycle roads and inter-village roads. So, authorities are cooperating with the Myanmar Police Force to take strict measures to control these illegal entries.
- 3. The ward/village administrators have been instructed to report, manage and send individuals who entered or came back to the ward/village to the quarantine centres.
- 4. To make the flow of goods smooth, truck drivers will be given the slip at the entrance gate. From the entrance gate, the drivers must drive their trucks directly to the exit gate, where the slip must be returned. The truck drivers are not allowed to go to other places between the entrance gate and the exit gate.
- 5. Face mask rule has been imposed in Nay Pyi Taw townships and COVID-19 awareness has been raised via loudspeakers. A dusk-to-dawn curfew has been in force, and surprise checks have been carried out on restaurants.

## Pulses exports exceed 1.5 mln tonnes in ten months (October-July)

MYANMAR exported over 1.5 million tonnes of multiple pulses and beans from 1 October to July-end in the financial year 2019-2020, earning over \$1.1 billion, according to the data of the Ministry of Commerce.

During a-year ago period, about \$940 million worth pulses and beans were exported. The export volume this year is relatively higher than that in the corresponding period of last year.

India is the leading buyer of Myanmar beans, especially black beans, green grams and pigeon peas. Besides India, Myanmar's beans are purchased by Bangladesh, Pakistan, Nepal, Dubai, Malaysia, Indonesia, China (Taipei), Japan, and European countries. But, the volume of demand by those countries is small, according to the domestic beans market.

India has been delaying to buy the beans amid the COVID-19 crisis, regardless of requirement in its supply, the

#### traders said.

On 22 May, India rapidly changed the import period of black bean to three months by August-end 2020 from the earlier set deadline of March 2021, as per their official notice.

Although the bean body

asked to extend the August-end deadline, India still has not responded to the request.

At present, Myanmar has exported about 100,000 tonnes of black beans out of 400,000 tonnes to India.

Myanmar ships over 1.6 mil-

lion tonnes of different varieties of pulses, especially mung beans, with an estimated worth of US\$1 billion, to other counties in the financial year 2018-2019. - Mon Mon

## Domestic investments top K1,881 bln, \$413.6 mln in previous FY

DOMESTIC investments by Myanmar citizens have reached K1,881 billion and US\$413.6 million in the previous financial year 2019-2020 since October, according to the statistics released by the Directorate of Investment and Company Administration (DICA).

Between 1 October and 29 September, Myanmar Investment Commission (MIC) and the respective region and state investment committees gave the green light to 103 local enterprises to invest in various sectors.

Domestic investments have flowed into the real estate, manufacturing, hotels and tourism, construction, industrial estate, energy, mining, livestock and fisheries, agriculture, and other services sectors.

The construction, manu-

facturing, real estate development, hotels and tourism and agriculture sectors pull the most massive investments made by Myanmar citizens this year.

Although Myanmar's economy is affected by the COVID-19 impacts, domestic and foreign investments are growing in the current financial year. The existing enterprises are also seen the expansion of capitals and an increase in the labour force, the MIC stated.

The Ministry of Investment and Foreign Economic Relations is inviting responsible businesses so the country benefits. The MIC is screening the investment projects at the soonest according to the COVID-19 Economic Relief Plan. - GNLM

## Myanmar citizens abroad cast advance votes for 2020 General Election

ADVANCE voting for the 2020 General Election began in Viet Nam, Eswatini, Bangladesh and Hong Kong vesterday.

Seventy Myanmar nationals in Viet Nam cast ballots at the Myanmar Embassy in Hanoi, and 17 citizens in Eswatini,

which has a total of 26 eligible voters, cast ballots in Matsapha.

Eighty-seven nationals in Hong Kong voted at the Myanmar Consulate-General Office in Hong Kong, while 27 in Bangladesh, which has a total of 29 eligible voters, cast their votes at the

Myanmar Embassy in Dhaka.

### New Caledonia rejects independence from France

THE South Pacific archipelago of New Caledonia voted against independence from France in a referendum on Sunday, full provisional results showed.

The 'no' camp won 53.26% of the vote, according to the archipelago's high commission, marking a narrower margin of victory than in a previous referendum in 2018.

French President Emmanuel Macron welcomed the referendum result with a "deep feeling of gratitude" in a speech from the Élysée Palace.

Sunday's independence referendum was part of a three-decade decolonisation effort aimed at settling tensions in New Caledonia between native Kanaks seeking independence and residents

willing to remain in France.

It's the second time the Pacific archipelago has gone to the polls to decide on its fate in two years. The first referendum in 2018 resulted in the maintenance of the status quo with 56.7 percent of the vote. The close result this time "opens the door to the possibility of a third independence referendum", noted FRANCE 24 international affairs editor Philip Turle.

But the 2018 result still marked a shift towards pro-independence sympathies, raising campaigners' hopes that this time it could manage to break free.

#### **High voter turnout** Enthusiasm was high and

## Washington, heart of US power, frozen by pandemic

BEHIND the giant bay windows of the World Bank, security guards remain at their posts, but idle. Outside, the sidewalks of Washington DC are largely empty. The bank is open, ready to host but its twice annual meetings with international financial institutions. But the meetings are all virtual these days.

Next door, at the HQ2 building of the International Monetary Fund (IMF) a sign says "temporarily closed." It has been hanging there for six months.

With just a month to go before the presidential election, Washington, the hub of American politics, is still in the social and economic deep freeze it was plunged into by the Covid-19 outbreak that began six months ago.

take part in upcoming meets at the World Bank and IMF will not stroll the sidewalks of the spruced-up city center, which before the pandemic had been touted as example of the regeneration of US downtowns.

Instead, they will be sitting at home, in front of their laptops.

As well as its political activities, the city had billed itself in the past two decades as a hub for international conventions and conferences. Before the pandemic, "we were experiencing record attendance and visitation to Washington, not only with congresses and meetings, but of course, also with the leisure market... and the international markets," said Elliott Ferguson, director of Destination DC.

Japan plant builder inks deal to construct key Iraqi oil refinery

THE PROJECT IN BASRA

JAPANESE plant builder JGC Corp. has signed a 400 billion yen (\$3.8 billion) agreement with an Iraqi state-run company to build a complex in one of the biggest operating refineries in Iraq as part of the country's reconstruction drive.

The project in Basra in southern Iraq will be funded through low-interest yen loans from the Japan International Cooperation Agency, the Japanese government's development aid arm. It is one of the agency's biggest ever financing projects in the Middle East.

Around 7,000 local skilled workers will be employed to build

the complex to extract heavy oil to produce more valuable lighter oil, such as gasoline. Another 2,000 jobs are expected to be created to operate the refinery, which is scheduled to be completed in 2025, according to the JGC. SOURCE: Kyodo

### Interpol issues 'red notice' for Thai Red Bull heir over hit-and-run

INTERPOL has issued a "red notice" to arrest the fugitive Thai heir to the Red Bull billions for his role in a fatal hit-and-run, police said Sunday. The move by the international police organisation is the latest in the years-long saga surrounding Vorayuth "Boss" Yoovidhya who crashed his Ferrari in 2012, killing a police officer. The charges against Vorayuth, who is the grandson of Red Bull's co-founder, were dropped in July -- sparking public outrage from Thais who saw it as an example of impunity enjoyed by the kingdom's elite.

It spurred probes by various government agencies, including the Attorney General's Office which last month announced fresh charges against Vorayuth of reckless driving causing death and cocaine use.

National Police spokesman Colonel Krissana Pattanacharoen confirmed Sunday a red notice -- Interpol's most urgent alert -- was issued earlier this week. "After we received the confirmation, we then passed our request to 194 member countries asking for assistance from them," he told AFP.

"We have to do whatever it takes to... ultimately bring him back to the country because it is a serious crime."

## Home containment is an effective option, but comes with responsibilities

ITH another 1,294 coronavirus cases confirmed yesterday, our country saw the number of cases increasing steadily for the fifth day in a row. Our country has now 17,794 cases of coronavirus cases and 412 deaths.

Over the past seven days, our country saw 978 on 3rd October, 1,142 on 2nd October, 1,010 on 1st October, 946 cases on 30th September, 797 cases on 29th September and 897 cases on 28th September. The cases that hit us is significantly upward, rising from around two digits in mid-August to nearly over 800 to 900 a day now.

The seven-day trend indicates the peak was probably three or four days ago.

Sunday's spike in the number of cases the largest daily increase registered in the country since the outbreak began in our country.

We believe that if the future situation will demand the health authorities to extend the capacities of current centres, which now have 7000 to 8000 occupants, the country will need to put all of our energies into it, and that will impact our health care system in the future.

Yangon saw over 1.000 cases in 24 hours on 3rd October. The number of Covid-19 cases is continuing to rise in

Yangon Region. We believe that if the future situation will demand the health authorities to extend the capacities of current centres, which now have 7000 to 8000 occupants, the country will need to put all of our energies into it, and that will impact our health care system in the future

It has become obvious that this is something we need to do in the long run. Whether we can reduce the current containment measures through allowing patients to remain confined at home, or not, remains a viable option in coping with the current situation.

Those who test positive need to quarantine themselves under the home containment scheme. Currently, a person who tested positive is taken to a COV-ID-19 centre or hospital. Under the home containment scheme, unless there are serious symptoms, home containment is enough. But, the patient must be under conditions — a 24x7 caregiver; constant communication

between the caregiver and a hospital; and immediate medical help if severe symptoms developed.

The government understands what it needs to do better. The pandemic rules are changing every day.

It becomes more critical as cases rise, and home containment should be taken into account for option for patients with no mild or no symptoms of the coronavirus disease.



# Virus spike means stricter control in Iceland

ICELAND, up to now one of the countries to have fared better against the coronavirus, has announced a tightening of restrictions after a spike in new cases since the middle of last month.

The health ministry said late Saturday that starting from Monday, most sports facilities, bars and discotheques will be closed while gatherings will be limited to a maximum 20 people. the capital Reykjavik re-opened only last Monday after a 10-day shutdown -- combined with general hygiene rules and social distancing in a bid to control the virus.

The latest steps come after coronavirus outbreaks in two nursing homes in Rekyavik and a sharp increase in hospitalisations, up seven-fold over a week.

#### WH chief of staff: Trump improving but doctors were 'very concerned'

THE US President responded well to treatment but doctor's continue to monitor condition.

White House Chief of Staff Mark Meadows said Saturday Donald Trump's health, including a fall in his blood oxygen level, had left the president's doctors "very concerned" but that he had improved and there was never a risk he would have to hand over power.

Earlier in the day a source familiar with the president's health -- later named in US media as none other than Meadows -- had given a contradictory assessment stating that "the president's vitals over the last 24 hours were very concerning." The statement also seemed at odds with an assessment by White House doctors that the president was "doing very well." Meadows seemed to clarify late Saturday that comments pertaining to concerningly poor health had applied to the day prior. "Yesterday morning, we were real concerned... he had a fever and his blood oxygen level had dropped rapidly," Meadows told Fox.

These restrictions will last two to three weeks, the ministry said.

"In recent days, the number of new cases on a daily basis has been relatively steady at 30 to 40 so it is clear that current measures have not been enough to adequately control the epidemic," chief epidemiologist Thorolfur Gudnason said in a statement addressed to the ministry.

Iceland's health authorities have adopted targeted measures -- for example discotheques in

"The hospital is not as well prepared to cope with an influx of patients as it was in the spring," Pall Matthiasson, head of the Iceland University Hospital, said in a message to the public and staff on its website Friday.

Over the past 19 days, Iceland has reported 663 new cases, mostly in Reykjavik and surrounding areas.

Iceland, home to 365,000 people, has recorded 2,872 cases and 10 deaths since the outbreak began early this year.

#### Japanese Gov't already planning approval of antiviral drug Avigan in Nov.

TOKYO — The Japanese government is already planning to approve the antiviral drug Avigan as a COVID-19 treatment in November even before its developer has filed for regulatory review, government sources said Saturday.

Under that plan,

the review of the influenza drug Avigan as a new coronavirus treatment will be completed in an unprecedentedly short screening period of three weeks once Fujifilm Toyama Chemical Co. submits a new drug application, expected in mid-October, the sourc-

es said, raising concerns about whether its safety and efficacy will be thoroughly scrutinized.

Despite some concerns about the drug's side effects such as birth defects, the Japanese government has been eager to get the health ministry to approve it as a coronavirus treatment and offer it to other countries.

Former Prime Minister Shinzo Abe came under fire in May for hyping up Avigan for treating COVID-19, saying then the drug's approval was expected within that month.—Kyodo

## Garcia, Davis, Poston share PGA Sanderson **Farms** lead

MISSISSIPPI — No-look Sergio Garcia and Australian Cameron Davis, who opened with five birdies, shared the lead with American J.T. Poston after Saturday's third round of the US PGA Sanderson Farms Championship.

Davis fired a US PGA career-low 63, nine-under par, while Garcia had a bogey-free 66 and Poston shot 69 to stand level on 14-under 202 after 54 holes at the Country Club of Jackson in Mississippi.

Garcia, seeking his first US PGA win since capturing the 2017 Masters, made six birdies and praised his new putting method of shutting his eyes while striking putts.

"It's quite simple," the 40-year-old Spaniard said. "What I'm looking for is to keep my stroke as smooth as possible. The less things I have in my head, or my eyes, the better.

"When I do it, I have a smooth stroke and I make a lot of good putts. When I don't, it's not quite as good."

Garcia, who has won three times on the European Tour since capturing the green jacket but is ranked a modest 51st in the world, sank an eight-foot birdie putt at the second hole.

He closed the front nine with back-to-back birdies from 12 and 15 feet and added tap-in birdies at the par-511th and par-4 12th.—AFP

### Football: Cavani set to join Man Utd - reports

LONDON - Manchester United are reportedly set to bolster Ole Gunnar Solskjaer's options up front with the signing of Edison Cavani on a free transfer, according to reports in the English and French media on Saturday (Oct 3).

The Uruguay forward has been without a club since leaving Paris Saint-Germain at the end of June. The 33-year-old is PSG's all-time top scorer, scoring 200 goals in seven seasons at the Parc des Princes.

The Daily Mail reported Cavani will sign a two-year deal at Old Trafford worth £210,000 (US\$270,000) a week after tax.

As a free agent, Cavani is still free to sign for a new club outside the transfer window, but French media reported the deal




