## Terrorist Attack in Maungdaw Region in October, 2016

- ❖ Terrorists attacked Koe Tan Kauk outpost, Yathaetaung township and Nga Khu Ya Police Station and No (1) Border Guard Police Headquarter (Kyi Kan Pyin) in Maungdaw township on 9<sup>th</sup> October, 2016.
- ❖ 6 members of Myanmar Police Force, 62 weapons of various types, 10130 rounds of assorted ammunition, 1 bayonet and 27 cartridges were lost.



# Terrorist Attack in Maungdaw Region in August, 2017

❖ ARSA terrorists cruelly killed Mro ethnic people working on the farms in the Mayu valley, about a mile in the north far from Kainggyi (NaTaLa), Zawmatet village-tract, Maungdaw township on 3<sup>rd</sup> August, 2017.

## Terrorist Attack in Maungdaw Region in August, 2017

- ❖ A coordinated attack on 30 border guard police outposts and one Tatmataw Headquarters, 31 outposts in total in Buthidaung, Maungdaw and Rathedaung townships, were attacked by ARSA terrorist.
- ❖ 10 members of Myanmar Police Force and 75 local ethnic people were lost.
- ❖ Some local ethnic people fled to the surrounding villages and townships.
- ❖ Bangali fled to Bangladeshi.

❖ 12- member family of Hindu, who lived in Myoma quarter of downtown Maungdaw were cruelly killed on their way back from Myinhlut town to Maungdaw, by ARSA who were already in District Court on 26<sup>th</sup> August 2017.

## Terrorist Attack in Maungdaw Region in August, 2017

- ❖ About 100 Hindi men, women and children from Yebaukkyar village, Maungdaw township were brutally killed in 25<sup>th</sup> August, 2017 terrorist attack.
- ❖ 28 dead bodies from two burrows, 1200 meters northwest of Yebaukkyar village on 24<sup>th</sup> September 2017 and 17 dead bodies from two burrows, 2000 meters in the east of the village on 25<sup>th</sup> September 2017 \_\_ 45 dead bodies in total.

- ❖ 35.3 miles by land and 38.6 nautical miles in the northwest of Maungdaw
- ❖ Bordering with Naikhongchri town, Bindarabin district, Bangladesh in the north and Ukheyar town, Cosbazzar district in the northwest
- ❖ U Soe Tun ( Deputy Director, General Administration Department) (Head of Reception Center)
- ❖ 104 staffs from 12 departments serve their duties in this Center




# Nga Khu Ya Reception Centre

- ❖ U Htay Maung ( Deputy Director/ General Administration Department)(Head of the Reception Center)
- ❖ 103 staffs from 11 departments serve their duties in this center




# Hla Phoe Khaung Transit Center

- ❖ **5.5 miles away in the north from Muangdaw**
- ❖ **7 nautical miles away from Teknaf, Bangladesh**
- ❖ **U Soe Aung ( Director/ General Administration Department) (Head of Center Management )**
- ❖ **45 staffs from 6 departments serve their duties**
- ❖ **48 people can stay in one shelter and (625) shelters are ready for (30000) returnees**

# Departmental Activities



## ❖ General Administration Department

- (1) Proper acceptance towards the returnees in collaboration with the respective departments**
- (2) Forwarding submission to take action against the investigated terrorists among the returnees in cooperation with the Myanmar Police Force**
- (3) Making arrangements for administrative affairs, food and shelter for the returnees during their temporary stay**
- (4) Imposing curfew, if necessary, coordinating with Deputy Commissioner**

# Departmental Activities

## ❖ Myanmar Police Force

- (1) Scrutinizing and supervising the returnees for the sake of security
- (2) Making measures on the security inside/outside the transit center
- (3) Making arrangements for casual scrutinizing



# Departmental Activities

## ❖ Immigration Department

(1) Inspection team verifies in terms of

- Immigration process,
- Issuing NVC
- Filling records of EID



# Departmental Activities

## ❖ Public Health Department

- (1) To arrange the medical aids for caring each and every returnee
- (2) To prevent epidemic diseases and if any outbreaks, to report the in-charge of the center
- (3) To arrange the aids for pregnant women to give smooth birth



# Departmental Activities

## ❖ Fire Brigade

- (1) To make preventive measures for fire outbreaks
- (2) To get the fire brigades ready for fire alerts
- (3) To arrange the necessary measures for natural disasters
- (4) To cooperate with the department concerned for ensuring water, including drinking water for the returnees



# Departmental Activities

## ❖ Department of Power and Electricity

- (1) To make measures for power supply in the streets and at the centers during the returnees' stay
- (2) To arrange measures for power supply at night while the staffs are on duty during the pre-mission period



# Departmental Activities

## ❖ Department of Disaster Management

- (1) To make measures for supplying each returnee with Longyis for men/women, T-shirts, soaps, blankets and foodstuff arranged by the department
- (2) To cooperate in administrative affairs




# Buildings between Border Post (34) and (35)

❖ It is agreed in Part 4, Paragraph 14, in the Treaty of the demarcation of the land boundary north of the Naf River (12-11-1998) that no construction is supposed to be built within the zone of 150 feet on each side of the boundary line.

“In order to make the boundary line easily identifiable and prevent the emergence of boundary- line- interested villages, neither High Contracting Party shall allow to build new houses or other structures of permanent or temporary nature, within a zone of 150 feet on each side of the boundary line”

❖ So, it is suggested that the two countries are supposed to handle the issue hand-in-hand because of the fact that the border shared by both communities is within the zone of 150 feet and is occupied by Bangalis.
