

Myanmar Rejects UN's Selective Biased Resolution

The Ministry of Foreign Affairs issued a statement on 17 November 2023 that Myanmar categorically rejects the whole resolution and dissociates itself from the adoption of the selective biased resolution of the UN at the Third Committee of the

78th United Nations General Assembly in New York, due to sweeping allegations and intrusive elements contained in the resolution as well as Myanmar's consistent position against the country-specific resolutions.

Statement

During the 78th United Nations General Assembly held in New York, a combined briefing on reports on Myanmar by the United Nations Secretary-General, Independent Investigative Mechanism on Myanmar (IIMM) and Special Rapporteur on the situation of human rights in Myanmar was made at the Third Committee on 23 October 2023. Additionally, the resolution entitled "Situation of human rights of Rohingya Muslims and other minorities in Myanmar" was adopted on 15 November 2023 without the participation of legitimate representatives of the concerned country, Myanmar.

The combined briefing was participated and briefed by Mr Khaled Khiari, Assistant Secretary-General of the Department of Political and Peacebuilding Affairs (DPPA) who was never mandated for such a task. Mr. Thomas Andrews, Special Rapporteur on the situation of human rights in Myanmar also presented his unethical and unprofessional report on 23 October 2023. Regarding the IIMM, the accuracy of the so-called twenty-three million pieces of information items said to be collected by the IIMM remains unknown since a functional tool to scrutinize them does not exist but solely depends on the self-interpretation of the mechanism. Myanmar has registered its objection with the United Nations against the acts of Kyaw Moe Tun in respective meetings under the banner of Myanmar as he has been representing the NUG terrorist group.

As in its previous versions, the resolution tabled by the EU and OIC on 15 November 2023 contained unfounded allegations from opposition groups and certain biased media.

While the resolution was tabled due to the incident in northern Rakhine State that occurred in August 2017, it intentionally excluded the root causes of that incident and reality on the ground. In fact, the mass displacement started in late September 2017, following threats, killings and coordinated attacks committed by the so-called ARSA aka Aqua Mul Mujahidin terrorist group in northern Rakhine State. Hundreds of displaced persons from camps in Bangladesh have been killed for not following the agenda of the terrorist group and for advocating the repatriation process whose realization has been

affected by such life threats. Myanmar stands ready to receive those who are verified as displaced persons from Rakhine State under the existing laws and bilateral arrangements signed between Myanmar and Bangladesh. The two sides keep negotiating to kick-start the repatriation of verified displaced persons. The Government of Myanmar has been repeatedly requesting Bangladesh's support for the early repatriation of the hundreds of displaced Hindus who volunteered to return. The repatriation process cannot be materialized only by Myanmar and cooperation from Bangladesh is required. Myanmar does not recognize the invented term "Rohingya" which has never existed in legal and historical records of the country.

The resolution fails to condemn the terrorist attacks committed by the so-called NUG and PDFs which have claimed the lives of over 6,700 unarmed civilians including more than 230 children. The said resolution itself amounts to hate speech and creates more polarization and escalation of tension among different communities in the country.

Due to sweeping allegations and intrusive elements contained in the resolution as well as Myanmar's consistent position against the country-specific resolutions, Myanmar categorically rejects the whole resolution and dissociates itself from the adoption of it. Myanmar expresses its gratitude to the friendly countries which dissociated themselves from the adoption of the resolution.

Statement on Destruction of Educational Buildings and Abducting of Faculty Members, Education Staff and Students by KNPP and PDF Terrorists

The KNPP and PDF terrorists intentionally opened fire at Loikaw University of Kayah State which is a non-military target, using heavy weapons and small arms and forcibly detained and abducted education

staff and students of the University. In this regard, the Information Team of the State Administration Council issued a statement that the terrorists must release those hostages without any injuries.

Statement

- 1. KNPP and PDF terrorists intentionally opened fire at Loikaw University of Kayah State which is a non-military target with heavy weapons and small arms on 13 and 14 November and surprisingly attacked security forces at the university with the deployment of excessive force.
- 2. These terrorist groups raided the university, destroyed educational buildings and illegally detained faculty members including the rector serving duties at the university, education staff and students. As such, security forces took necessary measures to timely save those faculty members and students not to suffering from injuries and to be safe.
- 3. Nonetheless, KNPP and PDF terrorists used educational staff and students as human shields in their attacks. As security forces controlled their moves so as not to cause unnecessary injuries to educational staff and students, they could save just some of them. Faculty members including the rector, educational staff and some students were forcibly abducted by KNPP and PDF terrorists. Moreover, it was found that KNPP and PDF terrorists brutally killed some faculty members.
- 4. In this regard, KNPP and PDF terrorists committed attacks and firing with the covers of educational buildings, which are important for the State and not military targets, forcibly detained faculty members, and educational staff as human shields instead of allowing them to escape from the dangerous area, intentionally attacked the university of a

hundred of educational staff and students, destroyed educational buildings and used these buildings as their covers in attacking. Hence, they violated the war crime under Common Article (3) of four Geneva Conventions and Article (52) of the Additional Protocol (1) as well as in accord with the customary international law in principle. Moreover, 15 member countries of the UN Security Council on 29 October 2021 condemned the attacks targeting schools, children and teachers and unanimously adopted Resolution No 2601 (2021) to protect those in the conflicts to have learning opportunities. As such, these acts of KNPP and PDF terrorists violated the UN Security Council Resolution 2601(2021) – the protection of Education in armed conflict.

- 5. Committing the attacks to target faculty members and education staff turning out good human resources essential for building a democratic nation and students who will shape the future of the State means destroying the future of the State, and this is not beneficial for anyone and an inhumane act intending to loss of the future of the country. Likewise, as their terror acts affected an unlimited postponement of examinations to be held in the third batch of the University of Distance Education, this brought tremendous loss to the students who will sit for the exam at the university on 13 November.
- 6. That is why the statement was issued that KNPP and PDF terrorists must release faculty members, education staff, students and their family members who are not absolutely concerned with the military affairs from illegal detention without any injuries.

Central Bank of Myanmar Issues a Statement regarding Banks



The Central Bank of Myanmar has issued a statement that bank services has remained convenient and the rumor going round about the banks are not true although some malevolence persons have recently been spreading false news on social network pages.

- People can withdraw cash from deposit accounts in banks. Since people can see the information about public deposit account in every branch of banks, according to Core Banking System, they can receive banking services at any branch.
- Myanmar's banking system uses the Core Banking System that provides interbank services, so if the service of a branch of a bank is stopped for some reason, people can still withdraw money at any branch of the bank nationwide. In addition, they can also use services like mobile banking, internet banking, payment cards as well as payments through

account transfer methods.

- money based on types of deposit they made. If they have made the Special Account, they can withdraw cash as the amount of money kept on deposit. If the account is Saving Account, people can withdraw once a week. If the account is Fixed Deposit, people can withdraw their money when the time becomes due.
- lion kyats set by the Central body on Anti-money laundering, the amount of cash has to be reported to Financial Intelligence Unit-FIU. Recently, those who withdraw much amount of money are to be monitored by CBM, Bureau of Special Investigation and FIU. So, harsh legal action will be taken against those who have been involved in manipulating market prices.

- Deposit cash in the bank is the money owned by depositor under any circumstances and at any time. These deposits will be at the accurate amount and accurate owner name in the banks and the depositors will be fully protected by the CBM.
- Circulating more money than needed outside of banks may lead to more inflation and higher commodity prices under the trick of those who are manipulating market prices in trading of housing estate, gold and foreign currency. Such doings may frustrate the stability of socioeconomic status of the people.
- Cash is filling in secured ATMs and the monetary system is being controlled as per international rules and regulations.

- So, petty cash in designated amount can be withdrawn at ATMs.
- The CBM is making cooperation with other law enforcement organizations to take harsh legal action under the law against those who are spreading false news to inflict the public interests.

In the current situation, there is enough cash in the banks, and the Central Bank of Myanmar is ready to provide cash to various banks, so the public should not withdraw more money than they need, and use banking services with confidence as usual, according to the CBM.



State Administration Council Information Team Leader Maj-Gen Zaw Min Tun Provides Updates on Ongoing Armed Conflicts and Measures Taken by the Tatmadaw



The State Administration Council (SAC) Information Team Leader Maj-Gen Zaw Min Tun provided updates on the ongoing armed conflicts in Shan State (North), Rakhine State, Loikaw of Kayah State, online scamming and rumours about the banking operations as follows –

- From 15 to 19 November, MNDAA/ TNLA groups launched attacks including drone strikes on the No. 290 Infantry Battalion in Tamoenye, and military outposts near Shin Khut Htan, Hopan, Namtsalat, Chinshwehaw Laukkai. Fire exchanges broke out and the enemy retreated with heavy casualties at every engagement.
- In Namt Phat Khar, MNDAA and TNLA terrorist groups fired motors into the public wards and civilian casualties were reported. In Kayah State, terrorist attacks in Loikaw have faced multiple failures by the insurgents. Measures are taken to

- ensure the security and safety of the Mandalay-Muse Union Highway which is critical for the people and the State.
- From 15 to 19 November, AA groups with an exceeding number of strengths repeatedly attacked the security outposts of Tron Ai, Nonebu, Donenyo, Pauk Taw local police station, Kalihta police station, Kotan Kauk outpost. However, due to the gallant and resilient defensive attacks of the Tatmadaw personnel and police force members, the enemy retreated with heavy casualties.
- For the same duration from 15 to 19 November, in Kayah State, Loikaw prison and court were attacked and burnt down.
 Moreover, the police outpost at Chaung Hna Khwa Bridge was also attacked and set fire. There were also engagements in Moebye and Demoso.
- Regarding the transportation situation on

the Mandalay-Muse Union Highway, 12 locations were destroyed by TNLA and PDF terrorists. Repairs along the road have been completed and will be extended.

- Combating online fraud is merely a reason for the current developments in the Kokang area. To achieve democracy is just a lie. The root causes of the conflict are the Pheung/Yang crisis, power games between Pheung Kya-shin group and Yang Moelyan families, and their hatred towards U Bai Xuoqian who was part of the Koekang administration mechanism.
- MNDAA and their alliances carried out measures to cause instability in the northeastern part of Shan State, manipulating the firm decision of the Myanmar and Chinese governments to eradicate online fraud.
- A total of 1017 Chinese nationals including 935 males and 82 females, who had lived in the border areas from 23 October to 19 November, were handed over to the Chinese Government after investigations as per relevant laws.
- Our government is actively cooperating with China for the stability and law enforcement at the border areas.
- A cache of arms and ammunition to be

- delivered to the KNPP and PDF terrorists doing sabotages in the Kayah State were confiscated together with the suspects in Pinlon town.
- Although rumours regarding the fuel oil appeared in the previous week, after the Government released the statement on the fuel oil, the rumours disappeared.
- Again, rumours appeared claiming that cash shortages occur in banks and cash withdrawals are being limited. In this regard, we assure the sufficiency of money.
- Every citizen is provided insurance for their deposits, transfers and withdrawals of their money from any bank officially recognized by the State Government.

Maj-Gen Zaw Min Tun added that the Tatmadaw leadership including the Head of the State have always recognized and respected the activities carried out by the security forces, military officers, Tatmadaw personnel, family members, Myanmar Police Force, and responsible citizens for their contributions to national defence and security duties. He urged the entire population to assist and support in the efforts to eradicate terrorist acts.

- Every citizen is provided insurance for their deposits, transfers and withdrawals of their money from any bank officially recognized by the State Government.



With the continuous arrivals of foreign tankers at Thilawa Port Terminal in Yangon Region, three oil vessels unloaded into respective storage tanks on 14 November, and two tankers are waiting to dock there. Additionally, more tankers are scheduled to arrive in near future.

• On 15 November, more than 1.2 million gallons of 92 Ron petrol, over 250,000 gallons of 95 Ron petrol, more than

700,000 gallons of diesel, and more than one million gallons of premium diesel were supplied day and night to 2,178 fuel-filling stations across the country.

• On 17 November, more than 1.4 million gallons of 92 Ron petrol, over 360,000 gallons of 95 Ron petrol, more than 1.15 million gallons of diesel, and more than 1.54 million gallons of premium diesel were supplied day and night to 1,602 fuel-filling stations across the country including Yangon Region.

 The Supervisory Committee on Import, Storage and Distribution of Fuel Oil formed investigation teams; inspected the status of selling fuel oil from fuel stations in Yangon and Mandalay Regions, and coordinated the efforts to meet the requirements of the customers.

Consequently, fuel supply has returned to normal conditions, and the people can now purchase fuel they need at every station in the country, it is reported.

Foreigners Involved in Online Scams and Gambling in Eastern and Southern Shan State Arrested

The Government is emphasizing the stability of the state and the prevalence of law and order. Under this context, security personnel arrested the foreigners who illegally entered Myanmar and have been doing online scams and gambling after receiving the reports about it.

- On 5 and 9 November when combined forces comprising security personnel made a surprise check for security reasons in Matman Township, eastern Shan State, they arrested 243 Chinese males and three Chinese females and two male Malaysians, who illegally entered Myanmar, three males and five females of Myanmar citizen.
- Again, combined security forces made a surprise check for security reasons on two motorbikes heading to Mong Yawng from Mongyu at the junction of Hokho near Tar Kyant village in Mongyu Township, one Chinese male and female nationality each, totalling two foreigners who illegally entered into Myanmar.
- According to the confession of arrested perpetrators, security personnel arrested eight Chinese males who illegally entered Myanmar and five Myanmar male citizens, totalling 13 at the home of Ko Min who rode the motorbike.
- When combined security forces made a surprise check for security reasons along

- the Wangpon-Sanphu road in Tarchileik Township, they arrested six males and one female of Chinese nationalities as well as one Vietnamese female, totalling eight foreigners, who illegally entered Myanmar, at the paddy field near Sanhu village.
- On 8 November when combined forces comprising security personnel made a surprise check for security reasons at the toll gate located at the entry of Kalaw Township in southern Shan State, they arrested seven Chinese nationals who illegally entered Myanmar.

According to the initial interrogation of the arrested perpetrators, they illegally entered Myanmar under various reasons to do online scams and online gambling in Myanmar territory. It is reported that they were hiding in some villages when security personnel searched them for arrest.

Necessary legal procedures are being carried out to take harsh legal action against a total of 286 arrested perpetrators: 270 Chinese nationalities, two Malaysians, one Vietnamese and 13 Myanmar citizens. It is announced that people can secretly provide the news to security forces about the groups and perpetrators who are involved in online scams and gambling if they know about it.

Myanmar Transfers Illegal Immigrants from Border Areas to Respective Authorities



The government is focusing on State peace, stability and rule of law. Moreover, the government is investigating and identifying the illegal immigrants from the border areas of Myanmar. On 19 November, 2023, 935 Chinese males and 82 females totalling 1,017 were identified. After the investigation process of the foreigners illegally residing in the border areas, they were systematically transferred to the authorities of the People's Republic of China.

As the government emphasizes prevailing rule of law in border regions, people need to cooperate with relevant security force for fostering rule of law in their regions, it is reported.

PDF Terrorists Launched Improvised Mortar and Drone Attacks on Urban Areas in Myaing Town



On 14 November, PDF terrorists launched mortar and drone attacks on urban neighborhood in Myaing town from the direction of its south-western and eastern parts. During the terrorist attacks, mortar shells hit No.2 Basic Education High School, injuring two female teachers and two other female students aged 11 and 12 respectively by pieces of shrapnel. Moreover, the mortar shells wrecked one school building as well as zinc roofing and ceiling of Township Public Hospital.

Armed insurgents who support terrorist acts and PDF terrorists are conducting a series of terrorist strikes on non-military targets of innocent civilians such as arson attacks on residential houses, shelling, impro-

vised-mortar attacks and drone attacks on road as well as bridge, neighborhood and villages in some townships of regions and states.

The said-victims were transported to Myaing Public Hospital to undergo medical treatment, and security personnel are continuing necessary security measures for peace and tranquility of the area, it is reported.

Three Chinese Suspects under Warrants Extradited to China

Three out of four suspects under warrants, namely Ming Xuechang, Ming Guoping (aka) Ming Xiaoping, and Ming Zhenzhen, were caught in Laukkai, Kokang Self-Administered Zone, Shan State. During the attempt to arrest them, Ming Xuechang shot himself with an illegally possessed pistol, and he died from that wound while undergoing medical treatment.

To take legal action against those arrested suspects, responsible personnel from the Myanmar Police Force handed them over to the Chinese counterpart at Yanlongkeng checkpoint at the Myanmar-China border on 16 November. The body of Ming Xuechang hasn't been brought back

to China yet for necessary verifications.

To eradicate organized crimes of online scam, seduction, kidnapping, illegal detention, and extortion, as well as to prohibit involvement in those crimes, the Government of Myanmar is striving with its utmost efforts in investigation, identification, and punishment by concerned law enforcement agencies. Additionally, the Government of Myanmar always keeps in touch with respective neighbouring countries and works actively in close cooperation, it is reported.

Perpetrators who Deliver Weapons and Ammunition to KNPP Group and PDF Terrorists in Kayah State Arrested



The KNPP group and PDF terrorists have been committing a string of terrorist crimes such as physical abuse of innocent civilians, threats to them, killing of civilians and act of vandalism.

The Government and the Tatmadaw have been putting an emphasis on the stability of the state and the prevalence of law and order across the nation for the security of socio-economic status of the people. In this context, security personnel arrested the perpetrator Khun Thaung Tun, owner of "New Power" petrol station in Lwetat village of Panmont village tract in Panlong Town, who have been delivering weapons and ammunition to KNPP group and PDF terrorists in Kayah State, on 16 November.

According to the confession of the perpetrator Khun Thaung Tun, security personnel arrested five perpetrators of Khun Aung Min, Khun Nay Myo, Kyaw Zin Tun, Khun Aung Kyaw Myint and Khun Aung Kyaw in the garage within the yard of Pay Too (aka) Mariano living in

Panmont village in Panlong Town. Along with them, 12 RPGs, nine China-made machine guns, 109 guns of Type-81 assault rifles, totaling 130 guns were seized. Again, a total of 7,632 bombs: 106 rockets of RPG, 6,100 Energa rifle grenades and 1,426 China-made handgrenades with connected string. Further, 13,670 bullets of 7.62 mm, 100 detonating parts of 107 mm rockets, 500 extra barrels for small arms, 1,829 magazines, 950 kilograms of TNT explosive charge, 200 kilograms of Amonium Nitrate, 2,000 equipment, three 'Canter' vehicles of six wheelers (without license), one 'Ford' vehicle (without license) and one 'Vigo' vehicle without license) were also seized.

 According to the confession of arrested perpetrators, security personnel arrested the fugitive Pay Too(aka) Mariao, who are mainly responsible for delivering weapons and ammunition to Kayah State, on 17 November. According to the confessions of the perpetrators Khun Thaung Tun and Pay Too (aka) Mariano, the seized weapons and ammunition were brought for four times from 10 people wearing SSPP/SSA uniform at Konkyaung village of Panlong Township. Then they stockpiled the weapons and ammunition in the garage. They confessed that they were arrested while they were planning to deliver those weapons to Kayah State by 'Canter' vehicle with six-wheelers.

It is announced that people can secretly provide the news to security forces about the delivery of weapons and ammunition by KNPP group and PDF terrorists, their hideouts and related perpetrators if they knew about it. Cash rewards are being presented to those who inform the report about it and help to arrest them. People are urged to participate in the efforts for the community peace and stability, it is reported.
