Pyidaungsu Hluttaw continues voting on proposals for constitutional amendment

PYIDAUNGSU HLUTTAW voted on amending provisions of 15 subsections and sections of the 2008 Constitution on its 20th day meeting of 15th regular session yesterday.

The second day of amendment voting was participated by 635 MPs, while 19 lawmakers were on leave.

Amendment proposals for the single paragraph (c) of Section 59 were submitted by the two lawmakers MP U Sai Than Naing and U Tun Aung (a) U Tun Tun Hein. Both proposals secured only 214 and 415 supporting votes, failing to pass 75 per cent that is required for the amendment process.

Moreover, proposals for amendment of paragraph (d) of Section 59 won 415 supporting votes, 393 votes for paragraph (f) of Section 59, 412 votes for paragraph (b) of Section 109, 412 votes for paragraph (b) of Sec-

tion 141, 414 votes for paragraph (d) of Section 161, 213 votes for Section 201, 411 votes for adding provisions into sub-paragraph (g-1) of Section 201, 411 votes for sub-paragraph (g-2) of Section 201, 409 votes for annulment of paragraph (k) of Section 201, 216 votes for adding provisions into paragraph (a) of Section 201, 226 votes for paragraph (c) of Section 248, 413 votes for Section 294, 408 votes for Section 410 and 410 votes for paragraph (b) for Section 411 did not cross the 75 per cent for

amendment.

Consumer rights campaign aimed to promote labeling commodities

THE Department of Consumer Affairs under the Ministry of Commerce launched a campaign to encourage labeling requirements for the businesses at its headquarters in Nay Pyi Taw yesterday morning.

Union Minister Dr Than Myint presided over the meeting and explained the Consumer Protection Law which was enacted on 15 March 2019, and it includes a chapter of labeling requirements for commodities. The campaign is intended to push producers for compulsory labeling their goods, to encourage the consumers being aware of labels on the commodities and to make suitable choice for the goods.

The six-week campaign will include broadcasting short films about consumer rights on stateowned media and social networks.

Only if we have been trained in the habit of being considerate to the other members of our community can our country have a chance to make progress. If you join an organization, for example, a scout association or a political party or an organization, because you join it out of your own will, you are required to follow the policies and rules of that particular organization.

What is the main point to consider is the aim and objectives of an organization. As the citizens of a country, this may lead you to consider what road the citizens want their country to take. Each and every individual must take it seriously, and understand it very well, and strive to the best of their abilities so that we can march forward straight. I often stress that it is through the individual's efforts combined with the collective strength of the people that our country will be able to make progress.

I would recall what my father said during the post-war period, before Myanmar regained her independence. Because our country had suffered severely during the wartimes, if we want to keep abreast with the other countries, we must set ourselves running while the other countries are walking. Now we have the same situation. Our country has been included among the least developed nations in Southeast Asia. So if we want to catch up with the world, we must set ourselves running. If, however, we walk as the others do, we'd be lagging behind. For example, we want to upgrade our education so we have made great efforts. Within these four years, our universities

have better ranking in the world. This shows signs of progress, but if compared with the universities of ASEAN countries, our ranking goes low. This means the other ASEAN countries have set themselves running faster than we do. No wonder, their ranking goes higher, and regionally, our ranking remains lower. So I said, we must make greater efforts.

One thing I often draw your attention to is a wealthy family is not the same as a poor family. When coming back home from school, the children of a wealthy family find the dinner table already laid. On the other hand, the children of the poor family have to help their parents first. Ours is like the latter case. If we want to make progress, we must make contributions of our own. And this is a good chance for you to be proud of yourself. Never adopt a negative attitude that we have to work very hard, but the positive attitude that we were born to do something for our country, that we have the privilege of contributing towards the progress of our country, that we have the citizens endowed with such special chances.

As for me, having a chance to work hard for our country is a thing of pride for us. We make our own decision, and out of our own will, we contribute towards the progress of our country, which is a great source of satisfaction and bliss for all of us. So I want the inclusiveness of all in this mission. During my visits all over the country, the local people's support and encouragement are very important, but such support shouldn't be a sort of blind support to us. That is why we hold public meeting so that our people will have a chance to get to know what the government is doing while the people will have a chance to discuss with us and make proposals. We must have a chance to hear your needs, your expectations and your worries that you express openly. That is why we always welcome your questions.

If it turns out that we have no more time left for discussion, you still have a chance to send your complaints to the section of complaints. Please feel free to mention your name, your address and the statements that you want to inform us. You must mention your name and your address so that we can respond. Another reason is that you must have a brave heart to speak out what you think is right. You don't need to hide your identity. If you are saying the right thing, you must not fail to mention your name and your address. So please mention your name and address. You can make contact with us. Mentioning your name and address means you stand bravely for what you believe is right.

During our visit to Dabayin, the local people may forward questions and proposals, but we must consider if these are local issues or the issues related to our country. The latter cases are usually the supply of drinking water, road transportation, electricity



In fact, these are the issues common throughout the country, and I would like to inform our people that we are trying our best to sort them out. For example, the supply of drinking water. It is the most important case for our people. Those living in shortage of drinking water know the troubles very well. So we have given priority to fulfilling the need of the sufficient supply of drinking water throughout the country.

Another important sector is road transportation. That's what we all want, what we all need. It is very important for the regional development, as well as for the sectors of health and education. Going to school or hospital would be a problem if there is no good road transportation. The consequences could be many.

I think I don't need to exaggerate the need for electricity. We want to make sure our people get the electricity supply. One point I often point out is that electricity doesn't merely mean just switching on the light at night. More than that. Electricity must guarantee that our people have a greater right to create our own destiny and build our own life.

I don't think I need to stress the importance of health and education. But what draws my attention these days is the people forward more cases of healthcare, and the forwarded cases are not merely related to fundamental healthcare, but the needs for advanced healthcare. This, we assume, implies that our country has more or less made progress in fundamental healthcare. I remember that two or three years ago the cases forwarded by the local people were related to fundamental healthcare.

To sum up, I realize, therefore, that our public gatherings like this truly reflect the changes taking place in our country. We always welcome the matters, related to the needs of our country, that you forward to us. I would like you to come up with the questions, as well as proposals, that are not self-centred, not directed to personal interests, but regionally oriented, for the sake of local needs, for the sake of the interests of our community, for the sake of national needs.

The State Counsellor, the Union Ministers and local officials responded to the questions raised during the discussions and gave advice and comments to ensure coordination.

After the discussions, the State Counsellor said, "We got to know the hopes, worries and issues concerning our citizens. And we were able to see the shortcomings of our people at the same time. In developing a nation, we cannot merely view things from an optimistic perspective. We need to be aware of our shortcomings and think of ways to amend them as well."

lar problems but different issues as well. We have to talk to the people the same things in one place, however, we have to give information differently in another place. This time I have to say the health issue as a priority. Why? The reason is that it's a critical issue for our country. You all know that the COVID-19 disease has been spreading across the world. State Counsellor said, "I'm very much delighted to come to Shwebo, a land of victory. I'd like to

with locals. Some audiences are strictly disciplined. Yet, some may have been more active than disciplined. Whatever it is, we need to realign the balance. We need to have both the discipline and activism. That's why all can participate to develop our country. "When I meet with the people I do exercise 'give and take' exchange of views all the time -- learning from them and giving information to them at the same time. We've convinced how we, as a Government, have to fulfill them whenever the people have been raising their requirements and proposals. I've noted that people may have a lack of understanding of legal issues, especially the laws and directives on owneror knives. Instead, they need to resolve their problem legally. It's more appropriate for one another. Laws are enacted in this way. Laws aren't right forever. It is the people that have invented to enact the laws. Human beings are drafting and enforcing laws.

"We should change the laws if necessary. Sometimes, we have to abrogate the laws. We have to substitute the laws where necessary. In this way, we need to get the laws live up to the circumstances. To enforce the laws is correlated to the current situations. Their existence may have ended if they aren't suitable for the necessities of the people. We have the laws of land ownership to hand over the confiscated lands to original owners as well as the virgin soil and uncultivated land to private owners. "The laws are many and varied. It is the Hluttaw, a legislative pillar, that drafts, enacts and makes them enforced. So the Hluttaw has been taking the leading role to ensure the rule of law upon the people. "The Government takes the administrative pillar. It has to perform day to day State affairs. It has to implement the matters of the State. In so doing, it has to

short and to the point. This will allow other people more opportunities as well. If you spend ten minutes for yourself, then it will end in about five people losing their two to three minutes to talk. You need to consider this."

"We need to consider the matters of other people and issues in addition to our own as we establish a democratic nation. We cannot focus just on our own matters. We need to be considerate of other people as well. We need to value the needs of other people express many thanks for your warm welcome. We came here not to talk about instructions but to create 'give and take' information exchange among one another during our journey to reach out to the people. In the same way, we as a Government have an opportunity to get the people informed. Therefore, I consider this as a 'give and take' information exchange programme between the people and their government. "We went to one place after another to find out not only simiship of lands. easy-to-understand programme for the people in this regard. We need to understand legal affairs to ensure a rule of law. Our people try to understand first what the laws are for.

"The main feature of the laws is for peace and stability in the community. The same basic principle we can see is in the ownership of lands. Two persons supposedly own the land. Their conflict may have turned to violence such as a fight with fists

do under the rule of law without breaching them. Here I want to quote 'Nobody is above the law'. Even however minor individuals in the country can't be above the law. Any pity and privilege can't be considered upon them. Courts may have taken into account 'sympathy' upon them. Only following the laws without any sympathy on the people may turn to extremes and toughness upon the people as a saying goes 'Sympathy can uphold the righteousness of the laws'. If we allow them for giveness with extra-sympathy, we can't control them in order under the rule of law even leading to anarchy status. The stability and security of the people can be disrupted in an anarchic country. The Government, an administrative pillar, has to carry out the laws enacted by the Hluttaw. The administration itself shall have to abide by these laws.

"Another one is the judicial pillar. It is basically to decide what is right and what is wrong according to the laws, through the courts. The laws may have different interpretations. The courts and judges shall have to hear the cases based on those different interpretations of the laws. They have to decide which side is right. We need to accept the fact that all the decisions made by the judges at the courts are correct and right. Judges may err since they're simply human beings. There are the appeal cases at upper courts or supreme court because the decisions of lower courts may have been wrong. The highest court or supreme court has to make final decisions. This is the rule of law.

"If we ask a question: 'Is there any corruption in the judicial pillar?' The answer is yes even around the world. We need to control it. To do this, our people take the most important role. We have attained these three pillars with people's wisdom and mindset. They need to carry on in the right way since all dignitaries of these three pillars are simply from the people.

"That's why we all are the people wherever they're with the Hluttaw, the judicial pillar, judges and legal officers, etc. They might be right. They might be wrong. All should try their best. We all do our best from the beginning. What I want to mean 'since we are young'.

"You see the children in the front row. They should have the correct mindset. With this, they dare to do the right thing. It's not enough. They shouldn't be indecisive to do the right thing by giving the reasons for laziness or fear or hardship or difficulty. They need to decide what should they do in the right way. That's education.

"So people should learn to develop our country. They need to ask themselves how they can do to give their best to the country. They don't need to look around. When we went to some places the people asked us whether the government is doing this and that, etc. We accepted their questions and thank you all for reminding us of our benefits. It is part of our dignity. However, people shouldn't forget that they also need to involve in certain things. Their participation is also very important.

"Our people should try hard to be good citizens of our country. I also believe in you. I'm confident that people can do their best. We should hand over good legacies to the next generation.

"We have the present moment. We own it according to an intelligentsia. So we should need to decide how to use the right moment to improve and develop our country and the people."

After the speech, the local people discussed requirement of rural clinics, compensations for confiscated lands,

land permits, illegal fish breeding ponds, electrification, needs for fire engines and water bowsers, new school buildings, land disputes, renovation of a bridge and the constitution amendment process.

The State Counsellor, the Union Ministers and local government officials responded to the discussions.

She also advised the locals to learn about the global outbreak of COVID-19 on newspapers and media platforms of the Ministry of Information as the death toll from this virus has reached to hundreds even in developed countries.

She finally made a wish for peace and wellbeing of the local people.

The State Counsellor instructed the administrative officials to reply to the remaining 26 questions of the local people on health, transportation and land disputes.

She also visited Aung Myay (Victory Land) pagoda in Shwebo Township, and offered flowers, water, lights and gold leaves as robes to the Buddha image. Then, she made wishes at the Victory Land of the pagoda.

VICE President U Henry Van Thio, in his capacity as Chairman of the National Water Resources Committee (NWRC), addressed the annual floods during the monsoon season and droughts in the summer, said the Vice President. He said they were working closeconcerned authorities to properly monitor against careless disposal of waste, dirty water or contaminated liquid from facto-

The Vice President said that as a substantial amount of the national budget is used in developing the water sector and its related components, everyone concerned should be vigilant in ensuring the projects were beneficial for the entire population, completed in time with minimal wastage, and with a vision that encompassed all river basins. Next, the Vice Chairman of NWRC, Union Minister for **Transport and Communications** U Thant Sin Maung, explained processes for developing the water sector, implementing the materialization of a national water law, completed and ongoing

processes related to decisions from the committee's previous meeting, preparations for the expected annual floods and

the committee's first coordination meeting of the year at Nay Pyi Taw yesterday.

He first reminded that these meetings aim to develop all sectors related or affiliated to water resources and to effectively manage them. He said these meetings have proven effective in resolving water-related issues and for coordinating with ministries and organizations involved in water resources.

In addition, the meetings have advanced preparations for

The Vice President said that as summer was approaching once more, concerned ministries, organizations and state/ regional governments must work together to prepare for shortages of drinking and irrigation water. He instructed annual pro-

The Vice President said the committee's task force has endeavoured for the emergence of a national water law and a draft has been compiled in English with a Myanmar version in progress. He said as part of the Ayeyawady Integrated River Basin Management Project, funded with loans from the World Bank, the office of NWRC and a hydro informatic center has begun construction in December 2019. droughts, conserving rivers and natural bodies of water, and preventing water pollution.

This was followed by other committee members and attendees explaining and reporting on their relevant assigned duties. The Vice President then responded to the discussions and urged everyone to continue their hard work in developing the water sector and livelihoods of all people connected to it. —MNA

Region. So, buses are packed at the bottom of the bridge from the Thanlyin Township side in the Southern District. Moreover, the YRTA will also cooperate with the township traffic police to provide assistance to students," he added.

"In the Southern District, crossing the Thanlyin bridge conveniently in less time is important for students who go to school. So, our YRTA southern district team has already made a plan to ease traffic on Thanlyin bridge. We have planned what we will do when there is traffic congestion on the bridge and when a vehicle breaks down on the bridge. What we are doing is also making more vehicles operational. We have faced similar problems. If something goes wrong on the bridge, we will take

students from the other side of the bridge to their schools," said U Hla Aung.

For the convenience of students during exams, we held a meeting with vehicle owners to resolve traffic problems, keep more buses running, and supervise normal bus lines so they operate regularly, he added.

"During this time of examination, it is important for students to reach school on time. So, we are keeping back-up buses so students can take their exams without issues," said U Hla Aung.

The matriculation examination for the 2019-2020 academic year is being held from 11 to 20 March. So, back-up buses are being operated for students so they can reach the exam venue easily, according to the YRTA. (*Translated by Hay Mar*)

Urgent need to finalize National Water Law to end summer shortage

IE summer of 2020 will be arriving soon, and it promises to bring searing heat to most parts of the country. The Department of Rural Development under the Ministry of Agriculture, Livestock and Irrigation has been taking preparatory measures to supply drinking water to villages that are expected to face drought in the summer.

In a welcome step, the department has announced hotline numbers as part of efforts to quickly respond to a possible crisis.

Regional authorities and related governmental departments are advised to coordinate with each other to overcome the challenges in the agricultural sector and in the provision of safe drinking water, especially in rural areas.

The problem of water shortage, which strikes rural areas every year, has alerted us of the need to prepare not only short-

The problem of water shortage, which strikes rural areas every year, has alerted us of the need to prepare not only short-term, but also midterm and longterm solutions to resolve the crisis.

term, but also mid-term and long-term solutions to resolve the crisis.

For a long-term solution, there is an urgent need to complete the drafting of the National Water Law and linking it with existing laws and rules and regulations.

While there are no easy solutions, we must turn this crisis into an opportunity by building artificial recharging structures, renovating the existing water harvesting systems, cleaning up water bodies, investing in water recycling, focusing on crops that are not water intensive, improving irrigation efficiency, and reducing water leakage, among other things.

However, the key factor will be making citizens understand that water is a finite resource, and it is critical to reduce consumption, maintain water supply facilities, and avoid actions which can

cause water scarcity and pollution.

Every citizen, whether a child or an adult, must understand the value of water and we must make efforts to raise awareness on and conserve our water resources

All citizens must stop littering bodies of water and participate in reforestation activities.

Our water problems are different from those in the Southeast Asian region though we possess 16 per cent of all water resources in Southeast Asia and 12 per cent in Asia.

We do have a dry zone in the centre of the country. That has added diversity to the climate conditions in Myanmar and added to our water problems. To put it simply, we do not get enough water, when and where we need it, due to uneven distribution of rainfall, changing pattern of hydrological conditions, and climate change.

To put an end to the water crisis in our country, we all need to step up our efforts for drafting the National Water Law, which will supersede all the laws related with water.

Yangon National Library -- Where Urban and Literary Heritage Converge By Thi Thi Minn, Photo By Nay Linn

STABLISHED since 1908 in the heart of Yangon, exactly on the Merchant Street in Pabedan Township, a hundred years old building would soon become a sophisticated urbane modern documentation venue in the name of National Library (Yangon).

Director Daw Yee Yee Htwe of the Library said, "The structure is under renovation and repair for quite some time. Currently, collections and documentations are in progress. Task is almost completed about ninety per cent. It doors for the public would open in the first week of April."

Earlier, the National Library (Yangon) is given access to the public at 85 (A) on Thiri Mingalar Lane, (Off) Kaba Aye Pagoda Road. For much easier accessibility for the general public, U Htin Kyaw, Former President had directed on 27 July 2016 to move the library to 604/608 on Merchant Street in Pabedan Township.

With speed, the building under reference is taken up for renovation and refurbishment, with the original architectural design intact, under the good eyes of professionals from the Yangon Heritage Trust; the people from architect circle; the skilled persons from construction sector; and the librarians. The work had started to roll on 1 July 2017.

"Being one hundred years old building with Yangon Heritage Trust Classification, it has not taken up lightly to change into an instant library. With the evaluation



of professionals and skillful per sons, the structure has been taken up for renovation," Director Daw Yee Yee Htwe explained.

Standing tall, the four-storied building has two beautiful entrances. Each and every floor has been maintained in national heritage style and that the walls have been embedded with mottos with regards to the library.

"Knowledge and Human Resources is inseparable"

"Let us use library for extensive reading to broaden the knowledge horizons"

Valuable remarks of former United Nations Secretary General U Thant could be seen as follows.

"Reading makes the people developed, and that the developed people go on reading".

At the extraordinary reading room for the differently-abled, books on general knowledge, inspirational literature, an assortment of writings in Braille, and several voice files have been provided to users.

Flowers and festivals round the year Myanmar composed and written by ancient scholar Pho Thu Daw U Minn could be enjoyed as they are depicted on the wall in English and in Myanmar.



The National Library is renowned as the place of comprehensive collections of printed materials published in the country, manuscripts and rare publications.

Grandeur of ground floor Intended as the future Exhibition Hall, the ground floor has been earmarked to showcase interesting items for the public. Colorful tiles with one hundred years' time span have been displayed at the entrance in attracting and catch-

ing the eyes of the guests to the library. Moreover, the Main Data Center of the library is allocated on the ground floor with full functioning. While the collection and display of the Yangon Library are

filling up the mobile shelves with motley assortments of various books and magazines of different eras in a neat, tidy and eye-catching manner.

One may climb up the normal stairways to the upper floor or may just step into the elevator to have access to other areas of the library.

For the comfort mobility of the persons with disabilities (PWDs), the paths for the use of wheelchairs have been fitted in

First floor presentation of the library

Equipped with modern facilities, the meeting and conference room for local event as well as foreign gathering with the capacity of 250 guests is being staged on the first floor.

Moreover, the Multi-Media Room with modern method of information gatherings is installed. The Multimedia Information System (MMIS) is a digital library system solely beneficial for the library users in getting international publications on wide-ranging subjects, various magazines, and research documents. Online data and information could be accessible along with self study for different languages.

At the digital library, users are accessible to an online data base in addition to the collection of data and information collected from the National Library

For those who wish to search data and information may have the opportunity at the digital library through online application. The room could accommodate (100) users.

The books upkeep at the National Library is accessible to the users as they have been systematically categorized and catalogued through modern techniques.

Arrangements at the second floor of the library

Welcoming the library users at the second floor is the general reading room, where cozy seats

are arranged for easy sitting and reading. The floor is filled with newspapers, journals, magazines printed and circulated within one year along with assortment of publications and books in English and in Myanmar presented in neat and systematic display in self browsing open-access shelves system.

"Shelf browsing is the act of finding books in a library by looking through the books on the shelves without consulting the catalogue first and without looking for any book in particular. One may just make a quick glance over the contents of the book", explained Director Daw Yee Yee Htwe.

What is more, the reference reading room on the second floor is furnished with varieties of books and documents on the topic Myanmar being written in Myanmar language as well as in the English language

Publications undertaken by the government departments, books for learners in different ethnic languages, printed items released in different ethnic languages, the publications from the United Nations, books written about the nations of ASEAN, and printed materials written in different foreign languages.

Readers have the opportunity to enjoy the books at their own pace and liberty. However, the books and documents from the reference room are not permitted to take outside

Moving ahead from the second floor, one can find the treasure of words presented in a most advanced, systematic and comprehensive manner.

Motley assortments of books and documents are there such as rare materials being preserved and maintained through successive eras published before 1948; the books and journals published before 1962; collections of Kinwun Min Gyi's literary works; collection of authoritative scholar Bagan Superintendent U Tin; collections of Bernard Free Library; collections of Palm-leaf manuscripts; Para Beik collections; handwritten literatures; the first ever newspaper in Myanmar called Maulmain Chronicle; the Yadanabon Nay Pyi Taw newspapers printed during King Mindon era; copies of newspapers being circulated during successive eras; rare books; and journals.

The original and substantive documents highly valuable for the researchers are systematically kept layer by layer in the room.

Director Daw Yee Yee Htwe continued, "The books are not permitted to take away from the room. They are to be read right here. Mostly, the information is converted into digital format could be available. In case if the researcher is in dire need to see the original documents, then the request could be complied."

As precautionary measure, all the books and documents are recorded and registered through Radio Frequency Identification for security reason. They are not supposed to take away from the premises of the library. telling room is provided for the attraction of the kids, as welcoming gestures to the young.

Htwe told, "In the initial stage, the associations working for the disabilities would lend hands in the reading campaign. For the visually impaired persons, the collections in Braille format included many inspirational books, the most popular book entitled Tway "Blood Bond" by Journal Kyaw Ma Ma Lay, tales and many other literature are collected and rendered as much as possible in the library."

On this particular floor, spaces are designated for the postgraduate library diploma; the short term training courses; the private group-wise discussion special room.

Jewellery traders facing cooling market due to COVID-19

JEWELLERY traders from the Gems Trading Centre in Maha aungmye Township in Mandalay are concerned over cooling trade on account of COVID-19, according to the Gems Trading **Executive Committee.**

"The market was expected to recover after the Chinese New Year. However, in my opinion, the market has been operational only 25 per cent even after the Chinese New Year, and in the midst of this situation, COVID-19 broke out around the world, starting from China, and this outbreak has aggravated the general situation. This being so, our local

jewellerv market has not been spared by this highly infectious disease. Usually, we sell jade to China. Now, Chinese traders are not coming to Myanmar to buy jade," said U Than Win, chairman of the Mandalay Mahaaungmye Gems Trading Centre.

"Jade sourced for the Mandalay Mahaaungmye Gems Trading Centre is coming mostly from the Phakant area, where local people are carrying out gemstone quarrying, and raw jade and jade stone mining. They are making jade sheets, jade bracelets, and jade rosary beads," he said.

"The jewellery market has cooled on account of COVID-19. The number of jewellery traders reaching the market has also declined by half. We are seeing only 30 per cent sales in the jewelry market," said U Myo Myint Naing, a jade trader.

Shops have been opened at the one-storey steel building outside the Mandalay Maha aungmye Gems Trading Centre. Nearly 200,000 people come to the Mandalay Mahaaungmye Gems Trading Centre every season. -Htet Htar Naing (IPRD)

Import of 11,000 tons of refined sugar permitted per month: **Commerce Ministry**

TO offset production of ers and sugarcane growers. low-quality sugar by local mills, regulate high prices due to high production costs, and support local beverage businesses, 11 enterprises have been allowed to import of 11,575 tons of refined sugar per month, starting from March, 2019, according to a notice released by the Ministry of Commerce.

The Ministry had allowed Myanmar merchants to re-export sugar in the 2015-2016 financial year with the aim of earning hard currency, improve trade, and create jobs. In late 2017, the ministry temporarily banned sugar re-exports to prevent weakening of the Kyat and thereby, regulate the forex market. Re-export permits were temporarily granted again in 2018. Between 1 June, 2018 and 16 August, 2018, the ministry issued 568 import licenses to 401 companies to import 921,099 tons of sugar under the re-export system. The stockpiles of sugar meant for re-export have been cleared, and the ministry is no longer issuing permits to traders, except 11 import-substitution businesses engaged in beverage production.

Moreover, government departments are combating the illicit inflow of sugar from foreign countries through the border areas, in line with the export-import law, as it can hurt the interests of local sugar mill-

To protect local sugarcane growers, re-exports needed to be banned, according to the Myanmar Sugarcane and Sugar **Related Products Manufactur**ers Association.

Myanmar produced about 450,000 tons of sugar on 440,000 acres of sugarcane plantations in the 2014-2015 fiscal year, over 390,000 tons on 390,000 acres in the 2015-2016FY, over 370,000 tons on 400,000 acres in the 2016-2017FY, over 500,000 tons on 400,000 acres in the 2017-2018FY, and 500,000 tons on nearly 500,000 acres in the 2018-2019FY.

Myanmar merchants import sugar mostly from Thailand and India, and also from Brazil, Qatar, and the UAE, and then it is re-exported to China through the Sino-Myanmar checkpoints, as Myanmar sugar millers are unable to produce quality sugar that meets the export criteria due to lack of advanced refining machinery.

More than 700,000 tons of sugar, worth \$394 million, was exported in the 2015-2016FY. Meanwhile, in the 2016-2017FY, 2 million tons of sugar, worth \$1.12 billion, was exported. Sugar re-exports were suspended from 22 September, 2017. -Ko Khant

Beijing says all international arrivals must quarantine for 14 days

BEIJING — Concerned over the imported cases of novel coronavirus, Beijing on Wednesday has issued directions for all international arrivals in the city, asking people to undergo self-quarantine for 14 days or face severe punishment.

The new order was issued

after Beijing Municipal Health

Commission confirmed six new imported cases of novel coronavirus disease (COVID-19) on Tuesday, five of the confirmed cases are from Italy, and one is from the United States, Xinhua reported.

Further tightening up quarantine checks at airports and employing epidemic prevention

measures in foreign communities, Chen Bei, deputy secretary-general of the Beijing Municipal Government, said that the Beijing Capital International Airport will designate Zone D of Terminal 3 as a special zone for inbound flights from countries with serious coronavirus situations.— ANI

Lithuania seeks to heal Soviet trauma after 30 years of freedom

VILNIUS — Seeking justice for victims of the Soviet regime to heal historical trauma has become a top priority for Lithuania as it marks 30 years since it became the first republic to break away from the USSR.

Take Auksute Ramanauskaite Skokauskiene, who is one of Lithuania's most prominent victims of historical trauma.

She spent her childhood living under an assumed identity to avoid Soviet authorities tracing her father who led Lithuania's armed resistance against Soviet rule in the Baltic state after World War II. Captured in 1956 and executed the following year. Adolfas Ramanauskas was only given a full state funeral some six decades later in 2018, after archaeologists identified his body in a mass grave.

"I always felt very disturbed that the Soviets slandered my

dad and other freedom fighters," Ramanauskaite Skokauskiene, a former MP and retired engineer, told AFP. "For me, it was very important that now I have a grave where I can come."

A big advocate of helping others like her to heal, Ramanauskaite Skokauskiene threw her support behind an unprecedented conference on trauma that featured prominent government officials. But the jury is still out on how much historic trauma hurts the country until this day. Lithuania left the USSR 11 on March, 1990 and has since enjoyed impressive economic growth — notably after joining the European Union and NATO in 2004.

But the Baltic nation of 2.8 million people struggles with some of Europe's highest rates of suicide, alcoholism and emigration.—AFP

Cardinal Pell lawyers say child sex conviction 'wrong'

CANBERRA — Lawyers for disgraced Cardinal George Pell claimed Wednesday he remains behind bars for child sex abuse based on "wrong" and "egregious" legal decisions, as they concluded a last-ditch appeal in Australia's top court.

The 78-year-old former Vatican treasurer is trying to overturn a six-year sentence for sexually assaulting two choirboys in the 1990s.

Pell, who once helped elect popes, is the highest-ranking Catholic Church official to be convicted of child sex crimes.

He was not present for the two-day hearing at the High Court in Canberra, but supporters and protesters gathered outside, waving Australian flags and carrying rival signs that read "keep the faith Cardinal Pell" and "Burn in hell Pell".

The court's seven judges

could decide to reject the appeal — leaving Pell to serve the remainder of his sentence -- or allow it, giving him the prospect of walking free. They could also send the case back to a lower court to reconsider.

A jury found him guilty in December 2018 on five counts of abusing the 13-year-old choirboys at a Melbourne cathedral when he was archbishop of the city.

That verdict was upheld in August 2019 by a three-judge panel in a 2-1 decision.

Pell's barrister Bret Walker told the High Court Wednesday there were "compounding improbabilities" in the case that had pitted the powerful clergyman against a former choirboy victim now in his 30s. Walker said the "shocking allegations" of sexual abuse were said to have taken place in a crowded cathedral and another public space, which he argued was "quite different" from typical sexual offending that tended to occur in "covert" settings.—AFP

UK health minister tests positive for coronavirus

LONDON — British MP Nadine Dorries, a minister in the health department, has tested positive for coronavirus, she said in a statement on Tuesday, raising concerns about whether senior government figures have been infected.

"I can confirm I have tested positive for coronavirus... and have been self-isolating at home," said the Conservative MP.

Health officials are now trying to trace where she contracted the virus and who she has been in contact with, she added. Six people have died in Britain from the virus, with more than 370 confirmed cases.

Dorries, who helped craft the legislation to fight the bug, is the first British politician to be diagnosed with COVID-19.

The Times reported that she had been in touch with hundreds of people, including Prime Minister Boris Johnson.

She fell unwell on Friday while signing the document that declared coronavirus a notifiable disease, meaning companies could obtain insurance cover, said the paper, adding she was now believed to be on the road to recovery.—AFP

Biden says fighting for US 'soul' after big primary wins

PHILADELPHIA — Joe Biden moved a giant step closer to a November showdown with Donald Trump after notching up big primary wins Tuesday over Bernie Sanders, his sole remaining challenger for the Democratic presidential nomination.

Biden, 77, the centrist former vice president, scored a resounding win in Michigan, where Sanders, 78, the leftist senator from Vermont, had hoped to make a stand.

He also cruised to victory in Missouri, Idaho and Mississippi, three of the other five states to vote on Tuesday.

Addressing supporters in Philadelphia as his victory took shape, Biden struck a presidential tone as he declared on national television that he would lead "a comeback for the soul of this nation."

"Tonight we're a step closer to restoring decency, dignity and honor to the White House," he said.

Biden reached out to his sometimes bitter rival Sanders and his supporters, telling them "we share a common goal."

"Together we'll defeat Donald Trump," he said.

Biden's huge victory in Mississippi, where he won around 80 percent of the vote, reflected his popularity among strategically vital African-American voters. He defeated Sanders by 25 points in Missouri.

His win in Michigan, the Midwestern industrial state which could be a key battleground in November, was a major setback for Sanders, who narrowly beat Hillary Clinton there four years

ago. Sanders led the count by less than 2,000 votes in Washington state, the other major prize of Tuesday's primaries, with around 70 percent of the vote counted on Wednesday morning. He was also leading by six points in North Dakota.

Barring surprises, Biden now has a clear path to becoming the Democratic standard bearer in a potentially bruising and deeply divisive matchup with Trump.—AFP

Netanyahu rival set for official protection after threats

JERUSALEM — Israeli Prime Minister Benjamin Netanyahu's challenger Benny Gantz is to receive state protection following online threats, the Shin Bet domestic security agency has announced.

"The prime minister has approved the Shin Bet's recommendation for close protection of Mr Gantz," a statement from the agency said late Tuesday.

The decision still requires ratification from a security committee. In Israel, seven people automatically receive protection from the Shin Bet, including the leader of the opposition.

But Gantz does not officially have that title as the country

has been stuck without a fully functioning government for more than a year, with three

elections unable to produce a decisive result. Since the most recent election on 2 March,

Gantz, who heads the centrist Blue and White party, has been trying to form a government. To do so he has sought the backing of the predominantly Arab Joint List, prompting attacks on social media from Jewish rightwingers.

Former armed forces chief Gantz took to Twitter on Saturday to call on Netanyahu to "stop this incitement to violence, do not say that you did not know."

He posted a message from social media saying "Gantz has to be killed as Rabin was."

Prime Minister Yitzhak Rabin was assassinated in 1995 by a rightwing extremist opposed to his peace deal with the Palestinians.—AFP



North Italy leader demands total shutdown over virus

ROME — The head of the Lombardy region around Milan urged the Italian government Wednesday to shut down all non-essential businesses and transport for 15 days in the industrial north to halt the spread of the novel coronavirus.

The appeal from Attilio Fontana came as Italy's death toll from the new disease shot up to 631 and infections surpassed 10,000, the worst numbers after China. The Italian fashion and financial capital Milan has already seen waves of government restrictions that led globally famous boutiques such as Armani to close their shops.

Fontana said he and 12 regional mayors decided more was needed to halt the spiralling spread of COVID-19.—AFP

Fighter jet crashes in Pakistan capital during parade rehearsal

ISLAMABAD — A Pakistani F-16 fighter jet crashed in Islamabad on Wednesday in an apparent accident during a rehearsal for an upcoming military parade in the capital, officials said.

There was no immediate word on the fate of the pilot or co-pilot, or details on the area the plane crashed.

Footage on social media showed a large plume of smoke billowing into the sky after the plane plummeted to the ground having apparently attempted a loop. "Pakistan Air Force reports with regret that a PAF F-16 aircraft crashed near Shakarparian, Islamabad during the rehearsals of 23rd March parade. Rescue teams have been dispatched towards the site of the crash," the air force said in a statement. A second security official speaking on condition of anonymity also confirmed the crash. The rehearsals were taking place before the annual military parade that is set to be held in Islamabad this month to celebrate Pakistan Day. F-16 jets are among the most valuable defence hardware in the Pakistani military's arsenal. The country has a fleet of about 50 F-16s, each worth at least \$40 million.-AFP

Convicted rapist Weinstein to learn prison term

NEW YORK — Harvey Weinstein faces up to 29 years in prison when he is sentenced by a New York judge Wednesday, two weeks after he was convicted of rape and sexual assault. The ex-Hollywood titan will be taken from the notorious Rikers Island jail to the Manhattan criminal court to learn his fate in court. Weinstein was cleared of the most serious charges of predatory sexual assault, as well as rape in the first degree, but will

at a hearing starting at 9:30 am (1330 GMT). Weinstein was found guilty of a criminal sexual act in the first degree and rape in the third degree on 24 February, in a verdict hailed by the #MeToo movement.

Seven men and five women convicted him of raping ex-actress Jessica Mann in 2013 and of forcibly performing oral sex on former production assistant Mimi Haleyi in 2006.

Mann, 34, and Haleyi, 42, are to due to deliver impact statements the

receive between five and 29 years behind bars.

Prosecutors called on Judge James Burke to issue a lengthy jail term, saying Weinstein engaged in a "lifetime of abuse" and had shown "a total lack of remorse" for his actions.

In a pre-sentencing letter, the prosecution asked Burke to consider 36 other sexual abuse and harassment allegations against Weinstein dating back to the 1970s that were not part of the trial.— AFP

Spurs forced back to drawing board after Champions League collapse

LONDON—Tottenham's 4-0 aggregate thrashing by Leipzig added the misery of an early Champions League exit to a season in which the 2019 finalists have been brought crashing back down to earth.

A never-say-die spirit carried Spurs to the club's first-ever final in Europe's top club competition last year after memorable fightbacks at Barcelona, Manchester City and Ajax.

Faced with the same mountain to climb, there was nothing left in the Tottenham tank during a 3-0 defeat in Leipzig on Tuesday.

The comeback against Ajax in the semi-finals was arguably the high point of Mauricio Pochettino's five-and-a-half-year spell in charge that turned his team from Europa League regulars into Champions League contenders.

Less than six months after Tottenham's 2-0 defeat to Liverpool in the Madrid final, Pochettino was replaced by Jose Mourinho, and it appears even the Portuguese does not believe
